## **MONDAY AUGUST 1**

The AFL wishes to advise the Match Review Panel has assessed the following incidents from the weekend's round of matches.

## Charges Laid:

Mark McVeigh, Essendon, has been charged with a Level Two striking offence against Steven Johnson, Geelong, during half time of the Round 18 match between Essendon and Geelong, played at Telstra dome on Friday July 29, 2005.

He can accept a one-game suspension with an early plea.

The incident was assessed as negligent conduct (one point), low impact (one point), behind play (two points) and high contact (two points). This is a total of six activation points, which relates to a Level Two offence drawing 225 demerit points a two-game suspension. He has no applicable good or bad record. An early plea would reduce the penalty by 25 per cent to 168.75 points and a one-game suspension.

This is a total of five activation points, which relates to a Level One offence drawing 125 points a one-game suspension. He has no applicable good or bad record. An early plea would reduce the penalty by 25 per cent to a reprimand and 93.75 points towards his future

**Chris Tarrant**, Collingwood, has been charged with a Level Four striking offence against Matthew Carr, Fremantle, druing the second quarter of the Round 18 match between Collingwood and Fremantle, played at the MCG on Sunday July 31.

His penalty is increased by 20 per cent due to a previous two-game suspension and he can accept a three-game suspension with an early plea. Tarrant's record means he faces a five-week suspension if he contests the charge and the charge is upheld by the Tribunal.

The incident was assessed as reckless conduct (two points), medium impact (two points), behind play (two points) and high contact (two points). This is a total of eight activation points, which relates to a Level Four offence, drawing 425 points and a four-game suspension. He has a previous two-game suspension, which increases the penalty by 20 per cent to 510 points and a five-game suspension. An early plea would reduce the penalty by 25 per cent to 382.50 points and a three-game suspension.

Other incidents assessed: No Charge Laid.

Contact between Essendon's **Dean Rioli** and Geelong's **Jimmy Bartel** from the second quarter of Friday's match was reviewed. It was the view of the panel Bartel jumped in the air prior to the tackle being applied by Rioli. Rioli took Bartel to the ground but his action did not constitute a spear tackle and therefore no action was

Contact between Essendon's **Dean Solomon** and Geelong's **Gary Ablett** from the third quarter of Friday's match was reviewed. The panel said based on the video footage and the evidence of the umpire which stated that Solomon made contact to Ablett with the inside of his arm and not a clenched fist, his action was deemed not to be a reportable offence.

Contact between St Kilda's **Brett Voss** and the umpire from the first quarter of Saturday's match was reviewed. The panel said contact was an accidental collision between the player and the umpire as the umpire attempted to back away while Voss sought to tackle. No further action was taken.

Contact between Melbourne's **Brad Miller** and St Kilda's **Robert Harvey** from the third quarter of Saturday's match was reviewed. The view of the panel was that the contact was made to the shoulder of Harvey but it was deemed to be minimal and therefore not reportable.

Contact between Melbourne's **Paul Johnson** and the umpire from the fourth quarter of Saturday's match was reviewed. A lack of video evidence and the uncertainty of the evidence meant the Match Review Panel could not deem if a reportable offence had occurred.

Contact between the Western Bulldogs' **Chris Grant** and the Brisbane Lions' **Troy Selwood** from the third quarter of Saturday's match was reviewed. Grant bumped Selwood to the head and a free kick was paid on the night. The panel said no further action was required.

Contact between Collingwood's **Chris Tarrant** and Fremantle's **Steven Dodd** from the third quarter of Sunday's match was reviewed. The view of the panel was that Tarrant made accidental contact to Dodd's head as he attempted to bump Fremantle's Troy Cook. No further action was required.

For charges laid by the Match Review Panel, clubs and players have until 10am tomorrow, Tuesday August 2, to decide whether to accept the penalty allocated, or to contest the case.
