## **Charges Laid:**

**Barry Hall**, Sydney, has been charged with a Level Two striking offence against Matt Maguire, St Kilda, during the first quarter of the first Preliminary Final between Sydney and St Kilda, played at the MCG on Friday September 16, 2005.

He is able to accept a one-game suspension with an early plea.

The incident was assessed as reckless conduct (two points), low impact (one point), behind play (two points) and body contact (one point). This is a total of six activation points, which relates to a Level Two offence, drawing 225 demerit points and a two-game suspension. He has no applicable good or bad record. An early plea reduces the penalty by 25 per cent to 168.75 points and a one-game suspension.

**Travis Gaspar**, West Coast, has been charged with a Level Two striking offence against Ken McGregor, Adelaide, from before the first bounce of the second Preliminary Final between West Coast and Adelaide, played at Subiaco on Saturday September 17, 2005.

He is able to accept a one-game suspension with an early plea.

The incident was assessed as negligent conduct (one point), low impact (one point), behind play (two points) and high contact (two points). This is a total of six activation points, which relates to a Level Two offence, drawing 225 demerit

points and a two-game suspension. He has no applicable good or bad record. An early plea reduces the penalty by 25 per cent to 168.75 points and a one-game suspension.

Contact between Geelong's **Steven King** and Melbourne's **Jeff White** from the third quarter of Saturday's match was reviewed. The panel said King and White contested a boundary throw-in, with White positioned behind King's left shoulder. The ball fell towards the right side of King and, as the ball was dropping and the area was clear, he swung his right foot to kick the ball as it fell. At the same time, White moved towards the ball to hit it with his left hand. King missed the ball and his right lower leg made contact with White's face in the follow-through. At no stage was King looking anywhere but at the ball. Despite the terrible injuries

suffered by White, the contact made by King was accidental and therefore was not a reportable offence. No further action was required.

Contact between the Kangaroos' **Glenn Archer** and Port Adelaide's **Warren Tredrea** from the first quarter of Sunday's match was reviewed. The panel said Archer swung his right arm towards Tredrea as Tredrea bumped him. The force involved in Archer's action was deemed to be below the level required to constitute a reportable offence.

The match day report laid against Fremantle's **Heath Black** for striking West Coast's Daniel Kerr was reviewed. The panel said the contact was viewed as a legitimate attempt to shepherd. The back of Black's arm made contact with Kerr's upper body and slides across his neck area, but it did not constitute a striking action and no further action was taken.

The match day report laid against the Kangaroos' **Brent Harvey** for tripping St Kilda's Justin Peckett was reviewed. The panel said the contact was an accidental tangle of legs between the two players and no further action was required.

The match day report laid against the Brisbane Lions' **Chris Scott** for striking Sydney's Amon Buchanan was reviewed. The panel said Scott made contact with an open hand to the back of Buchanan and this was not a striking offence.

Contact between the Kangaroos' **Glenn Archer** and St Kilda's **Stephen Powell** from the first quarter of Saturday's match was reviewed. The panel said the contact made by Archer was considered to be below the minimum required for a striking offence and no further action was taken.

Contact between Melbourne's **Brent Moloney** and Geelong's **Cameron Ling** from the first quarter of Saturday's match was reviewed. The panel said contact was made to the shoulder and not to the head and therefore no action was taken against the player for this reason only.

Contact between Collingwood's **Nick Maxwell** and Carlton's **David Teague** from the first quarter of Saturday's match was reviewed. The panel said Maxwell's action was a pushing action to the top of Teague's shoulder that slid up high and no action was required.
