### 90th Congress—Second Session

#### EXPLANATORY NOTE

The Voting Record is offered as a guide in judging the performance of Senators and Congressmen on issues of importance. Readers, however, will recognize the Record's inherent limitations. It is, of course, no measure of a legislator's creative ability or the diligence with which he performs his work in committee. It does not reflect on its face the failure of the Congress to deal with some major issues or the degree of responsibility of individual legislators. These judgments cannot be made in statistics or percentages; they require the use of other yardsticks and careful scrutiny on an individual basis of the capability and performance of legislators.

#### KEY TO SYMBOLS FOR HOUSE AND SENATE VOTES

- (+) Indicates a vote which ADA believes to be in harmony with liberal policies.
- (-) Indicates a vote which ADA believes to be contrary to liberal policies.
- (+p) Indicates a pair in favor of what ADA considers the liberal position.
- (-p) Indicates a pair contrary to what ADA considers the liberal position.
- (+a) Means the member was absent but was officially announced as favoring the liberal position.

(- a) Means a member was absent but was officially announced as opposed to the liberal position.

(A) Indicates the member was officially recorded as absent.

The number next to a Representative's name refers to his district.

(AL) means the Representative has no specific district but was elected "at large."

Democrats as the majority party are listed in boldface type, Republicans in light face.

Liberal Quotient (LQ) is the rating of a member's liberalism determined by the percentage of his votes cast, paired or announced, in support of liberal policy measured against the number of votes counted.



# SENATE ISSUES

**1. Civil rights.** Motion to invoke cloture on an open housing amendment. Motion adopted: 65-32, March 4, 1968. *A vote for the motion is a plus; a vote against, minus.*

Final and successful motion by Senate Majority Leader Mansfield (D-Mont.) to invoke cloture on the pending Dirksen (R-Ill.) open housing amendment which also provides penalties for interference with specific civil rights. A two-thirds majority is required to invoke cloture. With 97 Senators voting, 65 votes were needed to invoke cloture.

**2. Open housing.** Amendment which would have weakened provisions of the proposed open housing amendment. Amendment rejected: 43-38, March 5, 1968. *A vote against the amendment is plus; a vote for, minus.*

Senator Baker (R-Tenn.) offered the amendment to exempt from coverage of the pending Dirksen (R-Ill.) amendment's open housing provisions any single-family owner-occupied house sold or rented through a real estate broker or agent so long as the owner did not instruct the broker to discriminate or indicate to him an intent to discriminate.

**3. Assets disclosure.** Amendment to strengthen the proposed standards-of-conduct bill for the Senate by requiring Senators and Senate employees to disclose assets. Amendment rejected: 44-40, March 20, 1968. *A vote for the amendment is plus; a vote against, minus.*

Senators Clark (D-Pa.) and Case (R-N.J.) offered the amendment, which would have required Senators and Senate employees earning more than \$15,000 a year to file annual reports publicly disclosing the market value of each asset and liability, the source and amount of each capital gain and item of income over \$100, and the details of business and professional associations, including fees received for services.

**4. Federal spending.** Amendment which would have exempted certain areas from spending cuts proposed in the Williams (R-Del.)-Smathers (D-Fla.) amendment to the 10% surtax bill. Amendment rejected: 55-22, March 29, 1968. *A vote for the amendment is plus; a vote against, minus.*

The amendment, offered by Senator Javits (R-N.Y.), would have exempted from cuts spending for education, low-income housing,

water and air pollution prevention, prevention and detection of crime, the District of Columbia, training and employment of disadvantaged persons, and the war on poverty.

**5. Supplemental appropriations.** Conference report on urgent supplemental appropriations, which would have deleted a number of Senate-approved funds including \$75 million for the Labor Department's youth manpower training programs in the summer of 1968 and \$25 million for Head Start. Conference report rejected: 54-24, April 10, 1968. *A vote against conference report is plus; a vote for, minus.*

**6. Arms control and disarmament.** Amendment to extend the life of the Arms Control and Disarmament Agency (ACDA) for three years. Amendment rejected: 53-18, April 22, 1968. *A vote for amendment is plus; a vote against, minus.*

Senator Clark (D-Pa.) offered the amendment which would have extended the life of ACDA through June 30, 1971, and authorized \$33 million.

**7. Gun control.** Amendment by Senator Kennedy (D-Mass.) to omnibus crime bill which would have prohibited interstate mail-order sale of rifles and shotguns. Amendment rejected: 53-29, May 16, 1968. *A vote for the amendment is plus; a vote against, minus.*

**8. Omnibus crime bill.** Amendment to strike Title II from the bill. Amendment rejected: 51-31, May 21, 1968. *A vote for the amendment is plus; a vote against, minus.*

Senator Tydings (D-Md.) offered the amendment which would have struck the title relating to confessions, eye-witness testimony and judicial review by federal courts and providing for investigation on the impact of certain Supreme Court decisions on law enforcement.

**9. Omnibus crime bill.** Amendment to delete Title III. Amendment rejected: 68-12, May 23, 1968. *A vote for the amendment is plus; a vote against, minus.*

The amendment was offered by Senator Long (D-Mo.) and would have deleted from the omnibus crime bill the permissive wiretapping title (Title III).

**10. Hunger.** Amendment to make more funds for food distribution available through the De-

partment of Agriculture. Amendment accepted: 31-30, May 29, 1968. *A vote for the amendment is plus; a vote against, minus.*

Senator Javits (R-N.Y.) offered the amendment making available more funds for food distribution by removing language limiting the purposes for which the Department of Agriculture could use Section 32 funds (customs revenues).

**11. Anti-ballistic missile system.** Amendment to the military construction authorization bill delaying authorization for the Sentinel ABM system for one year. Amendment rejected: 52-34, June 24, 1968. *A vote for the amendment is plus; a vote against, minus.*

Senators Hart (D-Mich.) and Cooper (R-Ky.) offered the amendment which would have delayed the bill's authorization of \$227.3 million for the Sentinel ABM system until fiscal 1970.

**12. Juvenile delinquency.** Amendment to juvenile delinquency bill providing all funds in block grants to the states. Amendment rejected: 38-34, July 8, 1968. *A vote against the amendment is plus; a vote for, minus.*

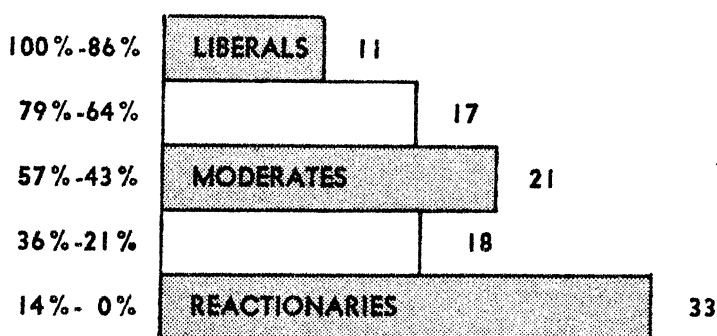
Senator Murphy (R-Calif.) offered the amendment which would have provided that all funds be allocated in block grants to the states, to be distributed by state governments under a statewide plan, if the grants were applied for by the state within six months of the bill's enactment.

**13. Head Start.** Amendments by Senators Dominick (R-Colo.) and Murphy (R-Calif.) to transfer the Head Start program from the Office of Economic Opportunity to the Office of Education. Amendment accepted: 60-29, July 17, 1968. *A vote against the amendment is plus; a vote for, minus.*

**14. Foreign aid.** Amendment to restore the authorization for economic assistance approved by the House Foreign Affairs Committee. Amendment rejected: 62-13, July 31, 1968. *A vote for the amendment is plus; a vote against, minus.*

The amendment, offered by Senator Clark (D-Pa.), would have restored to the foreign aid authorization bill \$317.5 million more than approved by the Senate Foreign Relations Committee.

# HOUSE ISSUES

1. **Civil rights.** Resolution to permit acceptance of Senate amendments to the House-passed civil rights bill. Resolution adopted: 229-195, April 10, 1968. *A vote for the resolution is plus; a vote against, minus.*

Rep. Madden (D-Ind.) moved the previous question on the resolution, thereby bringing it to a vote without debate and, in effect, expressing the House's willingness to accept the Senate's open housing and other amendments without change.

2. **HUD.** Motion by Rep. Bow (R-Ohio) to recommit the HUD appropriations act for fiscal 1968 to the House Appropriations Committee with instructions to limit fiscal 1969 expenditures to \$15.5 billion. Motion rejected: 217-173, May 8, 1968. *A vote against the motion is plus; a vote for, minus.*

3. **Higher education.** Amendment to the higher education authorization denying federal loans and grants to students who participate in certain campus demonstrations. Amendment accepted: 306-54, May 9, 1968. *A vote against the amendment is plus; a vote for, minus.*

Rep. Wyman (R-N.H.) offered the substitute amendment for the pending Pike (D-N.Y.) amendment. The substitute denies funds to students refusing to obey college regulations if college officials determine the refusal was "of a serious nature" and "contributed to the disruption of university or college administration." The Pike amendment would have denied funds to students who, during the previous 12 months, had "engaged in overt acts aimed at disrupting the national defense program."

4. **Omnibus crime bill.** Motion to disagree with Senate amendments to the bill and to request a conference to resolve differences. Motion rejected: 317-60, June 5, 1968. *A vote for the motion is plus; a vote against, minus.*

Rep. Celler (D-N.Y.) moved to disagree with Senate amendments which include additional

provisions on criminal law, wiretapping and gun control and to request a conference with the Senate to resolve differences.

5. **Public utilities.** Amendment to delete planning funds from the Dickey-Lincoln power project in Maine. Amendment accepted: 266-132, June 19, 1968. *A vote against the amendment is plus; a vote for, minus.*

Rep. Giaimo (D-Conn.) introduced the amendment which cuts the \$671,000 in planning funds designated for the Dickey-Lincoln power project in the Public Works-Atomic Energy Commission Appropriation for fiscal 1969.

6. **War on poverty.** Amendment by Rep. Scherle (R-Iowa) to cut \$100 million of OEO appropriations from the Labor, HEW, and related agencies appropriations bill. Amendment rejected: 220-181, June 26, 1968. *A vote against the amendment is plus; a vote for, minus.*

7. **Labor-HEW appropriations.** Motion by Rep. Flood (D-Pa.) to call the previous question on a motion to recommit the appropriations bill with instructions to limit total expenditures. Motion accepted: 275-126, June 26, 1968. *A vote against the motion is plus; a vote for, minus.*

Rep. Yates (D-Ill.) forced a roll call vote on the Flood motion as part of an attempt to include in the recommittal motion additional funds for schools. After the roll call, the recommittal motion, sponsored by Rep. Michel (R-Ill.), was rejected by a voice vote.

8. **Safety.** Motion to adopt House committee amendments lessening the authority—granted under the Senate-passed bill—of the Secretary of Transportation to set safety standards for gas pipelines. Motion accepted: 247-125, July 2, 1968. *A vote against the motion is plus; a vote for, minus.*

9. **Public housing.** Motion by Rep. Brock (R-Tenn.) to recommit the Housing and Urban



Development Act of 1968 and to delete grants to public housing authorities for tenant services and grants for interim assistance for blighted areas. Motion adopted: 217-193, July 10, 1968. *A vote against the motion is plus; a vote for, minus.*

10. **Foreign aid.** Motion to recommit the foreign aid authorization bill with instructions to cut an additional \$165 million from the bill. Motion adopted: 268-150, July 18, 1968. *A vote against the motion is plus; a vote for, minus.*

Rep. Adair (R-Ind.) made the recommittal motion which instructs the House Foreign Affairs Committee to cut \$75 million from Alliance for Progress, \$13 million from international organizations, \$55 million from supporting assistance, \$20 million from the contingency fund, \$2 million from administrative expenses—a total cut of \$165 million.

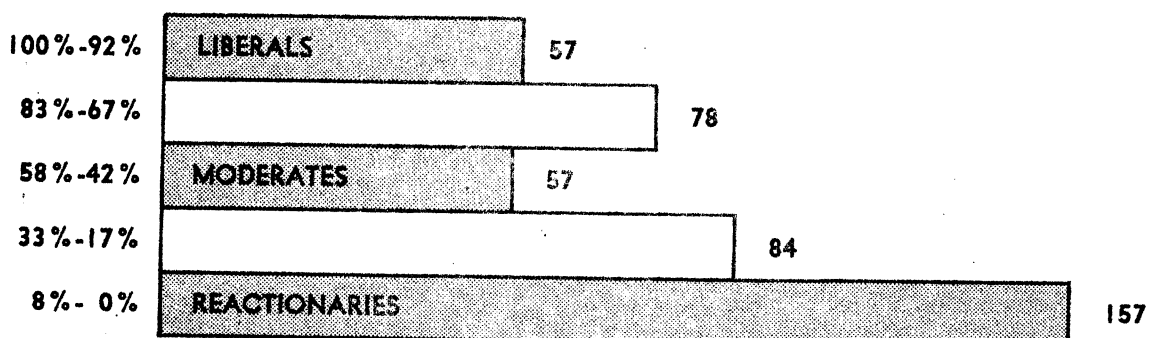
11. **Gun control.** Amendment to exempt certain ammunition from ammunition sale restrictions. Amendment accepted: 218-205, July 24, 1968. *A vote against the amendment is plus; a vote for, minus.*

The amendment to the gun control bill, offered by Rep. MacGregor (R-Minn.), exempts shotgun, rifle, and .22 caliber rim-fire ammunition from ammunition sale restrictions.

12. **Food stamps.** Amendment providing an unspecified appropriations authorization for the fiscal 1969-1972 food stamp program. Amendment accepted: 227-172, July 30, 1968. *A vote for the amendment is plus; a vote against, minus.*

The substitute amendment, offered by Rep. Sullivan (D-Mo.), provides an open-ended appropriations authorization for fiscal 1969-1972, instead of the proposed ceiling of \$245 million for fiscal 1969.
