



**PRODUCT SPECIFIC LICENSE TERMS**  
**Apeon® for PowerBuilder® 5.x Enterprise and Workgroup Editions (“Program”)**

IN ADDITION TO THE LICENSE TERMS SET OUT IN THE SYBASE LICENSE AGREEMENT, THE FOLLOWING ADDITIONAL OR DIFFERENT RIGHTS AND ACCOMPANYING OBLIGATIONS AND RESTRICTIONS SHALL APPLY TO THIS PROGRAM:

The Program contains or is provided with component software products from both Sybase and third parties. Except as otherwise specifically authorized below, use of all components is limited to use in the same manner and capacity for which the Program as a whole is licensed. Additional licenses may be available from Sybase for a fee. The Program may be used in conjunction with the Sybase® PowerBuilder (“PowerBuilder”) software product for the sole purpose of converting PowerBuilder applications into web-based applications and building new web-based applications.

**I. Restricted Use Components.** The Program contains or is provided with the Restricted Use Components identified below. You are licensed without further charge to Use only one (1) copy of each Restricted Use Component on one (1) Machine. You may Use the Restricted Use Components solely in conjunction with your use of the Program, and subject to any Additional Restrictions set forth below.

Restricted Use Components	Additional Restrictions
jConnect	May transfer copies to third parties provided (i) such third parties agree to be bound by all the terms and restrictions of this Agreement applicable to jConnect and (ii) you do not charge a fee to the third party
Adaptive Server® Anywhere	May only be used as a metadata repository

**II. EAServer.** The Program contains or is provided with the Sybase EAServer program (“EAServer”). You are licensed without further charge to use EAServer in the same manner and capacity for which the Program as a whole is licensed. Each copy of the Jaguar CTS component of EAServer is licensed for use on one (1) Machine only. Jaguar CTS may be accessed and used by (a) an unlimited number of "Internet Seats" (i.e., external Seats outside your organization accessing EAServer via the Internet) and (b) by an unlimited number of internal Seats (meaning your employees and contractors) using Jaguar CTS on such Machine in connection with their performance of duties for you, provided that you have paid the applicable fees for each CPU on such Machine.

**III. EAServer Manager.** Each copy of EAServer Manager licensed with the Program may be installed and run on an unlimited number of Machines.

**IV. Free Download Components.** The Program, including any Sybase components provided with it, may include certain third party open source and other free download components (“Free Download Components”). You may have additional rights in the Free Download Components that are provided by the third party licensors of those components. The Free Download Components and any such third party licenses and third party-required notices for the Program are identified at <http://www.sybase.com/thirdpartylegal> (third party licenses and notices for Free Download Components included as part of the Sybase components are identified under the names of those products). Any obligations undertaken by Sybase in the Agreement relating to the Free Download Components as part of the Program are provided by Sybase alone, and not by the third party licensors of the Free Download Components. **A. FURTHER DISCLAIMER OF WARRANTIES AND LIABILITIES.** The Free Download Components are provided “AS IS” by the third party licensors, who disclaim all liabilities, damages (even if they have been advised of the possibility of such damages), warranties, indemnities and other obligations of any kind, express or implied, with regard to the Free Download Components. Nothing in the foregoing affects any performance warranty provided by Sybase with regard to the Program as a whole. **B. DISCLAIMER OF INDEMNITIES.** The Free Download Components are excluded from any indemnity provided by Sybase or its subsidiaries in the Agreement. **C. The Program is provided with the following Free Download Components that are not a part of the Program, but are merely aggregated on the same medium with it: GNU Ghostscript from Artifex Software; ansi2knr.c from Aladdin Enterprises; and**

SmartFontMetrics from (URW)++ Design and Development ("GPL Software"). Notwithstanding anything to the contrary above or in the Agreement, THE GPL SOFTWARE IS PROVIDED "AS IS" BY SYBASE AND ITS LICENSORS, WITHOUT WARRANTY OR OBLIGATION OF ANY KIND. SYBASE PROVIDES NO SUPPORT FOR THE GPL COMPONENTS.

#### V. License Restrictions for Enterprise and Workgroup Editions of the Program.

**A. Terms Applicable to the Workgroup Edition of the Program.** A Workgroup license entitles you to access the Program from an unlimited number of Seats, provided that the Program is installed on only one (1) Machine running no more than two (2) CPUs. For the avoidance of doubt, each copy of the Jaguar CTS<sup>®</sup> component of the Program is also limited to use by a maximum of two (2) CPUs on one (1) Machine only. Jaguar CTS may be accessed and used by (a) an unlimited number of "Internet Seats" (i.e., external Seats outside your organization accessing the Program via the Internet) and (b) by an unlimited number of internal Seats (meaning your employees and contractors) using Jaguar CTS on such Machine in connection with their performance of duties for you.

**B. CPU License.** If your license for the Program is designated in an applicable Order as a CPU license, for each copy of the Program licensed by you for a designated Machine, you are authorized to use it on such Machine and to permit the Program to be accessed and used by (i) an unlimited number of external Seats outside your organization accessing the Program via the Internet ("Internet Seats") and (ii) by an unlimited number of your employees, agents and contractors (using the Program in connection with the performance of services for you), provided that you have paid the applicable fees for each CPU on such Machine. In the event that the number of processors on the Machine is increased, you shall report such increase and pay an additional amount determined by multiplying the incremental processors by the then applicable rate per processor set forth in Sybase's then current price list for the country in which the Program is to be installed. External Seats for persons other than your employees, agents and contractors accessing the Program via the Internet ("Internet Seats") may not use the Program to develop or modify applications or perform other programming tasks. You are not authorized hereunder to use this Program to host websites on behalf of third parties.

**C. Development and Testing License.** If your license for the Program is designated as a Development and Testing license, you are granted a limited right to Use the Program for development and testing purposes only and not in a production environment. Notwithstanding any other provisions of the Agreement or these Product Specific License Terms, the license fee applicable for each copy of the Program shall be determined by multiplying the total number of processors on a Machine by the applicable rate for each CPU as specified on the applicable Order. In the event that the number of processors on the Machine is increased, you shall report such increase, execute a new Order, and pay an additional amount determined by multiplying the incremental processors by the then applicable rate per processor set forth in Sybase's then current price list for the country in which the Program is to be installed. The number of users shall be limited only by the capacity of the licensed CPUs, and may include internal users within your organization, and external users outside of your organization accessing the Program via the Internet ("Internet Users"). Internet Users may not Use the Program to develop or modify applications or perform other programming tasks, and may only use the Program in conjunction with your applications.

**D. Hot Standby License.** If your license for the Program is designated as a Hot Standby license, you are granted a limited right to load a copy of the Program onto one or more Machines in a cluster environment where monitoring for a failure of the production copy of the Program occurs automatically and continuously and failover to the Hot Standby Program is automatic. A Hot Standby Program may not be accessed or used in production at the same time as the primary production copy. The Hot Standby Program must be licensed for the same number of Concurrent Users or CPUs, as applicable, as the production copy. Only upon a failure and failover of the production copy may the Hot Standby copy of the Program be used.

**VI. Sample Code.** You may use internally and modify the source code versions of those portions of this Program provided as sample code (e.g., code examples, sample applications and other such materials identified in the documentation), if any. Such source code versions may not be distributed to third parties. No implied license is granted in any copyright or patent rights of Sybase and its suppliers.
