



**PRODUCT SPECIFIC LICENSE TERMS**  
**SYBASE<sup>2</sup> Unwired Accelerator EVALUATION EDITION version 8.0**

THE FOLLOWING TERMS ARE EITHER IN ADDITION TO THE TERMS OF THE SYBASE LICENSE AGREEMENT ACCOMPANYING THIS PROGRAM (THE "AGREEMENT"), OR, TO THE EXTENT INCONSISTENT WITH THE AGREEMENT, ARE DEEMED TO MODIFY IT.

**A. LIMITED EVALUATION LICENSE**

**1. Limited Evaluation Use of Program.** Notwithstanding anything to the contrary in the Agreement, you may install and use the Program internally in your organization solely for evaluation purposes on a single computer system. You may not use the Program for any development, commercial or production purpose. The Program may not be transferred, sold, assigned, sublicensed or otherwise conveyed (whether by operation of law or otherwise) to another party without Sybase's prior written consent.

**2. Termination.** Your license to use the Program will automatically terminate as of the date ninety (90) days after you download or otherwise receive the Program. You acknowledge and understand that the Program may contain a license management mechanism that will render the Program unusable as of the date of termination. In addition, Sybase may immediately terminate this Agreement on notice to you. Upon termination, you shall cease using the Program and shall destroy all copies of the Program in any form.

**B. NO SUPPORT.** The Program is provided on an "AS IS" basis and is unsupported. Notwithstanding anything to the contrary in the Agreement, you are not entitled to any maintenance or other services or any updates or new versions of the Program.

**C. COMPONENTS.** The Program may contain or be provided with component software products from both Sybase and third parties. Except as set forth below, use of all components is limited to use in the same manner and capacity for which the Program as a whole is licensed. The terms of this Addendum govern the Sybase components provided with the Program, notwithstanding any other Sybase license documentation that may accompany those components. Additional licenses for Sybase components may be available from Sybase for a fee.

**1. Sybase Restricted Use Components.** The Program contains or is provided with the Restricted Use Components identified below. You are permitted without further charge to Use only one (1) copy of each Restricted Use Component on one (1) Machine. You may Use the Restricted Use Components solely in conjunction with your use of the Program, and subject to any Additional Restrictions set forth below.
