

## PRODUCT SPECIFIC LICENSE TERMS

## Adaptive Server® Enterprise (ASE) version 12.5.0.x-12.5.3.x Limited Life Versions (each a "Program")

IN ADDITION TO THE LICENSE TERMS SET OUT IN THE SYBASE LICENSE AGREEMENT ACCOMPANYING THIS PROGRAM, THE FOLLOWING ADDITIONAL OR DIFFERENT RIGHTS AND ACCOMPANYING OBLIGATIONS AND RESTRICTIONS SHALL APPLY TO THE PROGRAM FOR WHICH YOU HAVE PURCHASED A LICENSE.

The Program may contain or be provided with component software products from both Sybase and third parties. Except as set forth below, use of all components is limited to use in the same manner and capacity for which the Program as a whole is licensed. Additional licenses for Sybase components may be available from Sybase for a fee.

- I. Limitations on Use of the Developer's Edition and Small Business Edition of Program.
- A. Developer's Edition. The developer's edition of the Program is licensed for internal development and testing purposes only. Deployment licenses for any purpose (including, without limitation, usage in a general production environment or on a web server) must be purchased from Sybase before you deploy any production components contained in the Program.
- **B. Small Business Edition.** The small business edition of the Program is limited to use on a single Machine with a maximum capacity (as specified by the manufacturer) of four (4) CPUs or fewer.
- II. Sybase Developer Components/Distributable Components/Sample Code. The Program contains or is provided with the Developer Components identified below. The Developer Components are licensed without further charge for Use by one Standalone Seat for development purposes only. V. AS TO COPIES OF THE PROGRAMS LICENSED AFTER JULY 30, 2006, THE FOLLOWING TERMS AND CONDITIONS OF THESE PRODUCT SPECIFIC LICENSE TERMS SHALL APPLY. LICENSING OF THE PROGRAMS IS RESTRICTED TO "QUALIFIED LICENSEES" (AS DEFINED BELOW). ENGINEERING SUPPORT AND MAINTENANCE IS SCHEDULED TO BE DISCONTINUED FOR THE PROGRAMS ("END-OF-LIFE"). PLEASE REVIEW THE DETAILS BELOW CAREFULLY.

- A. Qualification as Licensee. If you are a direct end user of Sybase, You are not authorized to purchase licenses for a Program unless you have previously purchased a license for version 12.5.0.x, 12.5.1.x, 12.5.2.x or 12.5.3.x of the Program prior to July 30, 2006 ("Qualified Licensee"). If you are a Qualified Licensee, you are authorized to Use the additional number of copies of the Program set forth in the Order in accordance with the Agreement. You represent that you are a Qualified Licensee. If you have purchased a license for the Program after July 30, 2006 and you are not a Qualified Licensee, please contact Sybase immediately.
- B. Limited Support and Maintenance Availability; Scheduled End-of-Life. Standard Sybase support and maintenance (if purchased) will only be provided for the Programs in accordance with the Agreement through July 30, 2007. Thereafter, Sybase will only address P1 (severity level 1 issues), and shall have no other obligation with regard to support or maintenance. The Programs will be End-of-Life Programs as of September 30, 2008 (or July 30, 2009 for localized versions) ("EOL Date"). After the EOL Date, Sybase shall have no obligation or liability whatsoever with regard to maintenance or support of the Programs. Sybase may in its discretion elect to make limited technical assistance available, subject to the availability and personnel and other resources, and subject to a separate Sybase support contract for such Programs on terms and conditions that must be agreed to between you and Sybase.
- C. Discontinuance of Compatibility with ASE 15.x. On or after November 30, 2007, the Programs' ODBC driver and OLE DB functionality (which is licensed to Sybase by Data Direct or its predecessors) will be disabled (by means of a time-bomb or other mechanism) so that it will no longer function with ASE versions 15.x or later.
- D. No Licensing of Programs After July 30, 2009. You will not be able to obtain any additional copies of the Programs after July 30, 2009.
- E. FURTHER DISCLAIMER OF OBLIGATIONS AND LIABILITIES AS TO PROGRAMS LICENSED AFTER JULY 30, 2007. The following additional disclaimers and limitations apply to all copies of the Programs licensed after July 30, 2007.
  - Additional Disclaimer of Warranties. Notwithstanding any provision of the Agreement, the Programs and related Services, if any, are provided "AS-IS", WITH ALL FAULTS and WITHOUT ANY WARRANTY OR CONDITION OF WARRANTY.
