CITY COUNCIL MATTERS

7. CITY COUNCIL CONSENT CALENDAR

a. **Approving** - minutes of September 2, September 23, October 7 and October 14, 2003. Recommended by City Clerk.

ACTION: Minutes approved.

b. **Matters to be set for public hearing** - on Tuesday, November 18, 2003.

Federal Local Law Enforcement Block Grant Funds - consideration of authorizing the use of Local Law Enforcement Block Grant funds in the amount of \$101,555 and approving an appropriation of \$11,284 from the Citizen's Options for Public Safety (COPS) California State Grant funds program to meet the grant's matching funds requirement.

ACTION: Public hearing set for November 18, 2003.

Proposed Amendment to the Municipal Code - Multiple Family Rental Dwelling Unit Inspection and Maintenance Code, and Amendment to the Multi-Family Housing Inspection Program - consideration of amending Chapter 14 (Buildings and Building Regulations), Article XIV (Multiple-Family Rental Dwelling Unit Inspection and Maintenance Code) to provide clarification and establish additional exemption options to the Multi-Family Dwelling Inspection Program, including a self-certification option.

ACTION: Public hearing set for November 18, 2003.

Awarding - contract for Project 115.1, Bonifacio Street Drainage Improvements, to Sposeto Engineering, Inc. as the lowest responsible bidder in the amount of \$45,888.80 for the Base Bid and Alternate 1, and approving a \$15,700 related budget transfer. Bids were opened at 10 a.m. on September 16, 2003. Recommended by Director of Public Works-Engineering Services.

ACTION: Contract awarded and budget transfer of \$15,700 approved.

d. Accepting - improvements for 2003 Patch Paving Program, RFQ #1918, constructed by MCK Services, Inc., and directing the City Clerk to file the Notice of Completion. Recommended by Director of Public Works-Maintenance Services.

ACTION: Improvements accepted; Notice of Completion to be filed.

e. Accepting - improvements for Project No. 132, Traffic Signal Installation and Site Improvements at Intersection of Concord Boulevard and Clayton Way, constructed by W. Bradley Electric; approving a \$25,000 related budget transfer; and directing the City Clerk to file the Notice of Completion. Recommended by Director of Public Works-Engineering Services.

ACTION: Improvements accepted; Notice of Completion to be filed; budget transfer of \$25,000 approved.

f. Accepting - improvements for Project No. 172, Monte Gardens/San Vincente

Area Sewer Rehabilitation Phase 2, constructed by RePipe California, Inc., dba PPR of Santa Ana, and directing the City Clerk to file the Notice of Completion. Recommended by Director of Public Works-Engineering Services.

ACTION: Improvements accepted; Notice of Completion to be filed.

 g. Approving - new classification of Parks and Recreation Customer Service Coordinator (ATC Pay Grade 7), and reclassification of the affected incumbent with status, effective 11/10/2003. Resolution 03-3493.1 for adoption. Recommended by Assistant City Manager.

ACTION: Resolution 03-3493.1 adopted.

h. **Approving -** year-end budget adjustments for Fiscal Year 2002- 2003 and related budget adjustments for Fiscal Year 2003-2004. Recommended by Director of Finance.

ACTION: Budget adjustments approved as recommended.

8. CITY COUNCIL PUBLIC HEARINGS

Citizen's Options for Public Safety (COPS) Grant - consideration of approving the expenditure plan for Fiscal Year 2003-04 Citizen's Options for Public Safety fund grant in the estimated amount of \$186,055 to be used for front line municipal police services. Resolution 03-55 for adoption. Report from Captain Barry Dansie.

ACTION: Resolution 03-55 adopted, approving the expenditure plan as recommended.

9. CONSIDERATION - of an agreement with the Public Enterprise Group to facilitate development of an exclusive Beverage/Snack Marketing Partnership Agreement, and authorizing the City Manager to execute the agreement. Approval recommended by Council Committee on Recreation and Cultural Affairs. Report from Director of Parks and Recreation Mark Deven.

ACTION: Agreement with the Public Enterprise Group to facilitate development of an exclusive beverage/snack marketing partnership agreement not approved as recommended and referred back to staff to review other revenue generating options (3-2; Bonilla and Peterson, No).

10. CONSIDERATION - of approving the Shaping Our Future (SOF) Principles of Agreement, which incorporates the concept of the SOF vision for future countywide growth and

development, and serves as the foundation for moving ahead with the SOF project. Resolution 03-62 for adoption. **Report from Principal Planner Phillip Woods.**

ACTION: Resolution 03-62 adopted, supporting the SOF vision for growth in the county and approving the Principles of Agreement; staff directed to send a letter from the Mayor to the County Board of Supervisors (Board) indicating the City's support and urging County Supervisor's support for the SOF Principles and supporting the recommendation regarding the Urban Limit Line as described in Supervisor Millie Greenberg's letter; and requesting the Board abandon their proposed ballot initiative.

Mayor Peterson reported on his recent attendance at the nationally televised De La Salle football game and congratulated De La Salle on their 145th consecutive win.

There is a 90-day limit for the filing of a challenge in the Superior Court to certain City administrative decisions and orders which require a hearing by law, the receipt of evidence, and the exercise of discretion. The 90-day limit begins on the date the decision is final (Code of Civil Procedure Section 1094.6). Further, if you challenge an action taken by the City Council in court, you may be limited, by California law, including but not limited to Government Code Section 65009, to raising only those issues you or someone else raised in the public hearing, or in written correspondence delivered to the City Council prior to or at the public hearing. The City Council may be requested to reconsider a decision if the request is made prior to the next City Council meeting, regardless of whether it is a regular or special meeting (Policy and Procedure No. 2, Section 4.24).
