#### 5. CITY COUNCIL CONSENT CALENDAR

 Approving - lease agreement with Cingular Wireless to install antennas on a ballfield light standard and construct a small utility enclosure in Willow Pass Park; and authorizing the City Manager to execute the agreement.
 Recommended by Director of City Management.

ACTION: Agreement approved; City Manager authorized to execute it.

b. **Approving** - extension of cable television franchise agreement with Comcast to May 4, 2004 and authorizing the City Manager to enter into a contract amendment with the Contra Costa Cable Consortium in the amount of \$26,000 to fund the formal cable franchise renewal process; and approving a related budget transfer. Approval recommended by Council Committee on Infrastructure and Franchise. Resolution 03-59 for adoption. Recommended by Director of City Management.

ACTION: Resolution 03-59 adopted, approving agreement extension and contract amendment; \$26,000 budget transfer approved; City Manager authorized to execute documents.

c. **Approving** – an amendment to the employment agreement between the City of Concord and Edward R. James, City Manager. Recommended by Mayor Peterson.

ACTION: 1.5% increase in salary approved, to be effective July 7, 2003, for an annualized salary of \$200,581; one-time \$10,000 performance bonus awarded (4-1; Hoffmeister, No.)

d. **Approving** – an amendment to the employment agreement between the City of Concord and Craig Labadie, City Attorney. Recommended by Mayor Peterson.

ACTION: 1.5% increase in salary approved, to be effective July 7, 2003, for an annualized salary of \$175,103; one-time \$5,000 performance bonus awarded.

e. **Approving** - agreement for professional services with ATS Engineering Services for the design of lighting improvements at Sun Terrace and Willow Pass Parks, Project No. 931, in the amount of \$9,000; and authorizing the City Manager to execute the agreement. Recommended by Director of Public Works-Engineering Services.

ACTION: Agreement approved; City Manager authorized to execute it.

f. **Accepting** - improvements for Project No. 188, Highlands Park Lighting Improvements, constructed by Jacino Electrical, and directing the City Clerk to file the Notice of Completion. Recommended by Director of Public Works-Engineering Services.

ACTION: Improvements accepted; Notice of Completion to be filed.

g. **Awarding** - contract for RFQ #1947, Remove and Replace Asphalt Concrete Parking Lot of Batting Cages at Willow Pass Community Park, to Granite Construction Company as the lowest responsible bidder in the amount of \$47,150.00. Bids were opened at 9 a.m. on October 24, 2003. Recommended by the Director of Public Works-Maintenance Services.

ACTION: Contract awarded as recommended.

#### 6. CITY COUNCIL PUBLIC HEARINGS

Sycamore Grove Rezoning and Preliminary Development Plan - consideration of an application by SummerHill Homes to amend the Zoning Map from Medium Density Multiple Residential (M-1.8) to Planned District (PD), and for a Preliminary Development Plan to construct 45 single-family detached homes on a 4.79-acre site at 3994 Willow Pass Road; and determination that a negative declaration with mitigation measures and monitoring program is the appropriate environmental document. The City Council may be requested to reconsider a decision if the request is made prior to the next City Council meeting, regardless of whether it is a regular or special meeting (Policy and Procedure No. 2, Section 4.24).
