1. ANNOUNCEMENTS

Vice Mayor Hoffmeister announced four openings on the Concord Human Relations Commission and set Friday, April 2, 2004 as the deadline for receipt of applications.

CITY COUNCIL MATTERS

2. CITY COUNCIL CONSENT CALENDAR

a. **Approving** - agreement with Kwan Software Engineering, Inc. for the purchase of Veripic, a digital photo management system and supporting hardware, including digital cameras and CD burners, and authorizing the City Manager to execute the agreement; and approving a related budget transfer in the amount of \$55,000 from the Asset Forfeiture Fund. Recommended by Chief of Police.

ACTION: Agreement approved; City Manager authorized to execute it.

2. CITY COUNCIL CONSENT CALENDAR - contd.

b. **Approving** - agreement with Lawson Software in the amount of \$881,166 for the purchase of financial and human resources enterprise software pursuant to RFP 1865, and authorizing the City Manager to execute the agreement. Recommended by Director of Finance.

ACTION: Agreement approved; City Manager authorized to execute it.

c. **Approving -** award of contract for the 2004 Patch Paving Program, RFQ #1957, to G. Bortolotto, Co., Inc. as the lowest responsible bidder in the amount of \$539,918.89. Bids were opened at 2 p.m. on February 18, 2004. Recommended by Director of Public Works-Maintenance Services.

ACTION: Contract awarded as recommended.

d. **Accepting** - improvements for Removal and Replacement of Asphalt Concrete Parking Lot of the Batting Cages at Willow Pass Community Park, RFQ #1947, constructed by Granite Construction Company, and directing the City Clerk to file the Notice of Completion. Recommended by the Director of Public Works-Maintenance Services.

ACTION: Improvements accepted; Notice of Completion to be filed.

3. CONSIDERATION - of Contra Costa County initiation of Request for Proposals process to convert Buchanan Field Airport from aviation use to alternative urban development. Report from Assistant City Manager Lydia Du Borg.

ACTION: Alternative #1 selected, formally opposing the County's initiation of a Request for Proposal (RFP) process that seeks to convert Buchanan Field from aviation use to alternative urban development, and urging the County to halt the process, pursuant to the comments made in City Manager Ed James' letter dated February 11, 2004, with the addition of concerns regarding the impact on medical and emergency response capabilities; Mayor directed to send a letter to the County (3-1; Bonilla, No).

There is a 90-day limit for the filing of a challenge in the Superior Court to certain City administrative decisions and orders which require a hearing by law, the receipt of evidence, and the exercise of discretion. The 90-day limit begins on the date the decision is final (Code of Civil Procedure Section 1094.6). Further, if you challenge an action taken by the City Council in court, you may be limited, by California law, including but not limited to Government Code Section 65009, to raising only those issues you or someone else raised in the public hearing, or in written correspondence delivered to the City Council prior to or at the public hearing. The City Council may be requested to reconsider a decision if the request is made prior to the next City Council meeting, regardless of whether it is a regular or special meeting (Policy and Procedure No. 2, Section 4.24).
