3. CITY COUNCIL CONSENT CALENDAR

Mayor Bonilla announced that the City had become aware after the publication of the evening's agenda of the need for the City Council to approve a Resolution adopting the National Incident Management System (NIMS) Principles and Policies into the City's Emergency Management System prior to a September 30, 2006 deadline to be eligible for FY 2007 funding opportunities. A motion was made, seconded and unanimously approved to add the following item:

 Approving – the adoption of the Principles and Policies of the National Incident Management System (NIMS) and implementing mandated NIMS Training for all of Concord employees to comply with Homeland Security Presidential Directive, Management of Domestic Emergency Incidents. Resolution 06-66 for adoption. Recommended by Chief of Police.

ACTION: Resolution 06-66 adopted.

a. **Approval of Minutes -** of September 5, 2006. Recommended by City Clerk.

ACTION: Minutes approved.

b. **Approving** - revisions to Policy and Procedure No. 34, entitled "Business Meeting Attendance and Travel Authorization and Reimbursement of Expenses" to include language consistent with the requirements established with the passage of AB 1234. Recommended by Director of Human Resources.

ACTION: Policy and Procedure No. 34 approved; Administrative Directive No. 43 acknowledged.

c. Adoption of Ordinance 06-10 - Amendment to Concord Municipal Code – Tobacco Retailers License Ordinance - repealing Chapter 38 (Health and Sanitation), Article III (Tobacco Advertising Restrictions) in its entirety and adding a new Chapter 38 (Health and Sanitation), Article III (Tobacco Retailers License Program); and establishing a new fee for the license and various other administrative charges associated with the program, which will cause amendment to the Master Fees and Charges for Various Municipal Services Resolution. Ordinance 06-10 introduced on September 5, 2006.

ACTION: Ordinance 06-10 adopted.

d. **Approving -** the amendment to the Master Fees and Charges for Various Municipal Services adding the Tobacco Retailers License Program Fees to Section B of Exhibit "A" to Resolution 78-6042. Resolution 06-6042.4 for adoption. Recommended by Director of Finance.

ACTION: Resolution 06-6042.4 adopted.

e. **Approving** - a second amendment to the Professional Services Agreement with Gillarde Planning and Consulting in an amount not to exceed \$35,000 for the continuation of development review services bringing the total contract price to \$74,500; and authorizing the City Manager to execute the amendment. Recommended by Director of Planning and Economic Development.

ACTION: Amendment to the Agreement approved; City Manager authorized to execute it.

f. **Approving** - modifications of the Memorandum of Understanding Between the City of Concord and the Concord Peace Officers Association representing the Police Managerial Representation Unit for the period July 1, 2006 through June 30, 2007. Resolution 06-4735.4 for adoption. Recommended by Director of Human Resources.

ACTION: Resolution 06-4735.4 adopted.

g. Accepting - the improvements for Project No. 2017, Installation of Pool Heaters at Concord Community Pool, constructed by Pool Scene, Inc. of Sacramento; and directing the City Clerk to file the Notice of Completion. Recommended by the Director of Building, Engineering, & Neighborhood Services.

ACTION: Improvements accepted; City Clerk directed to file a Notice of Completion.

h. **Approving** - Project No. 2060, Bridge Preventive Maintenance Plan; and appropriation of Caltrans Bridge Preventive Maintenance Program Grant Funds in the amount of \$24,345 to the project. Recommended by Director of Building, Engineering and Neighborhood Services.

There is a 90-day limit for the filing of a challenge in the Superior Court to certain City administrative decisions and orders which require a hearing by law, the receipt of evidence, and the exercise of discretion. The 90-day limit begins on the date the decision is final (Code of Civil Procedure Section 1094.6). Further, if you challenge an action taken by the City Council in court, you may be limited, by California law, including but not limited to Government Code Section 65009, to raising only those issues you or someone else raised in the public hearing, or in written correspondence delivered to the City Council prior to or at the public hearing. The City Council may be requested to reconsider a decision if the request is made prior to the next City Council meeting, regardless of whether it is a regular or special meeting (Policy and Procedure No. 2, Section 4.24).
