The Concord City Council/Redevelopment Agency met in a regular joint meeting on Tuesday, May 23, 2006 at 5:30 p.m. in the City Council Conference Room. Vice Mayor Peterson was absent. PROFESSIONAL SERVICES AGREEMENT - Moore lacofano Goltsman, Inc. (MIG)

This item was removed from the calendar by staff to allow Julia Dos Santos to present a report on the Americans with Disabilities Act (ADA) Transition Plan Update required of the City. She stated that the City is required to conduct a self evaluation and would be holding two public meeting to receive input from the citizens of the community.

Joseph V. A. Partansky, Concord, commended the City on the effort and asked that all historical data on ADA matters be given to the contractor hired to prepare the Plan.

Motion was made by Hoffmeister and seconded by Shinn to approve a professional services agreement with Moore Iacofano Goltsman, Inc. (MIG) of Berkeley in the not-to-exceed amount of \$226,889 for Project 2035, ADA Transition Plan Update; to approve a related budget transfer in the amount of \$27,000; and to authorize the City Manager to execute the agreement. Motion passed by the following vote of the Council:

ESPLANADE GENERAL PLAN AMENDMENT AND MUNICIPAL CODE AMENDMENT

The notice of public hearing was published in the Contra Costa Times, mailed to all interested and affected parties, and posted in the Civic Center posting cabinet on May 9, 2006.

Mayor Bonilla announced that the City had received a letter from the developer asking that the item be continued due to family health matters. Motion was made by Allen and seconded by Shinn to continue the item to Tuesday, July 25, 2006 at 6:30 p.m. without opening the public hearing and that the item be renoticed to all parties and a legal notice be published in the newspaper. Motion passed by the following vote of the Council:

PROPOSED MUNICIPAL CODE AMENDMENT - Cable Ordinance Amendment

The notice of public hearing was published in the Contra Costa Times, mailed to all interested parties, and posted in the Civic Center posting cabinet on May 9, 2006.

Motion was made by Shinn and seconded by Hoffmeister to continue the public hearing to consider a proposed amendment revoking in its entirety Concord Municipal Code Chapter 102 - Telecommunications, and Article II - Cable Communications, and replacing with a new Chapter 102 - Telecommunications, and Article II - Cable Communications, to update standards to Tuesday, July 25, 2006 at 6:30 p.m.

Joseph V. A. Partansky, Concord, stated that in his opinion the Cable Ordinance was independent of the Comcast Franchise Renewal which is also recommended for continuation, and that the matter should be heard.

ADOPTION OF RESOLUTION 06-32 - Comcast Franchise Renewal

The notice of public hearing was published in the Contra Costa Times, mailed to interested parties, and posted in the Civic Center posting cabinet on May 12, 2006 and May 17, 2006.

At the recommendation of staff, motion was made by Allen and seconded by Hoffmeister to continue the public hearing to consider a 15-year non-exclusive cable television franchise agreement with Comcast, renewing the current agreement with new terms and conditions as recommended by the Council Committee on Infrastructure and Franchise. Motion passed by the following vote of the Council:

GENERAL PLAN UPDATE - Eliminate Concord Naval Weapons Station From the Project

Principal Planner Phillip Woods presented a report, referring to his memorandum dated May 23, 2006 stating that based on testimony received at the April 19, 2006 Planning Commission meeting, the City Council was being asked to review and consider whether there is a conflict between the process and timeframe for the General Plan Update which was initiated in March 2003, and the recently initiated Concord Community Reuse Project. He further stated that the Federal Government's approval of the closure of the inland area of the Concord Naval Weapons Station and the proposed General Plan update for that area has caused some confusion within the community. The proposed action, he said, would provide the opportunity for the Council and the community to review the future of the Naval Weapons Station property without language imposed by the General Plan update document.

Following comments from the Council, the public comment period was opened.

Resident Kathy Gleason read a letter she had submitted to Council dated May 23, 2006.

Ken Fickett, resident of Orinda; Mike Daley, representing the Sierra Club of Berkeley; James Dugart, Concord; and Ursula Luna, Concord, each expressed their desire to remove the Concord Naval Weapons Station from the General Plan Update.

Ray O'Brien, Bay Point, stated his desire to see representative of all the local communities represented on a panel to determine the future development of the Concord Naval Weapons Station.

Sandy Johnson, Concord, requested the definition of the term "open space."

Keith McMahon, Concord Chamber of Commerce, and Ken Clarke, Concord, each stated that they would like the General Plan Update to proceed as initiated.

The public comment period was closed and the Councilmember made comments.

Motion was made by Allen and seconded by Hoffmeister to accept the Planning Commission's recommendation to refocus the General Plan Update and shift the emphasis to the existing urban area by taking out the proposed development parameters for the Concord Naval Weapons Station. The motion passed by unanimous vote of the Council.

CITY COUNCIL SITTING AS THE LOCAL REUSE AUTHORITY

PROFESSIONAL SERVICES AGREEMENT – Environmental Risk Services Corporation

Motion was made by Shinn and seconded by Hoffmeister to approve a professional services agreement in the amount of \$140,000 with Environmental Risk Services Corporation (ERS) for the Concord Community Reuse Project environmental data research; and to authorize the Local Reuse Authority Executive Director to execute the agreement. Motion passed by unanimous vote of the Authority.

PROFESSIONAL SERVICES AGREEMENT – Garrity and Knisely

Motion was made by Shinn and seconded by Hoffmeister to approve a professional services agreement in the amount of \$210,000 with Garrity and Knisely for the Concord Community Reuse Project legal services; and to authorize the Local Reuse Authority Executive Director to execute the agreement. Motion passed by unanimous vote of the Authority.
