WORKSHOP PRESENTATION – Summary Results on Concord Community Reuse Plan

Mayor Bonilla introduced Daniel Iacofano of Moore, Iacofano, Goltsman, Inc. (MIG) who gave a summary of the results of several activities conducted to receive community input on the Concord Community Reuse Plan for the future civilian use of the Concord Naval Weapons Station, and shared information collected by a citywide survey. He stated five major themes emerged from the activities, including Planning Considerations, Community Development, Parks, Recreation and Open Space, Economic Development and Transportation, and he gave an overview of the comments received concerning each theme. Mr. Iacofano introduced John Kaufmann who gave an overview of the results of the citywide survey and encouraged continued community involvement in the process.

The meeting recessed at 10:50 a.m. and reconvened at 11:10 a.m.

Following comments by the Council, a public comment period was opened.
