8 **A RESOLUTION concerning**

10 **Towing Rates**

11
12 **FOR** the purposes of increasing towing rates for towing companies licensed by
13 the City of Annapolis and authorizing additional minimum charges.

14
15 **WHEREAS**, the Annapolis City Code, Section 7.52.120, requires the City
16 Council to approve the towing and storage fees charged by those
17 towing companies licensed within the City of Annapolis; and

18
19 **WHEREAS**, the Office of the City Clerk is responsible for licensing, and the
20 Annapolis Police Department is responsible for regulating and
21 inspecting towing companies; and

22
23 **WHEREAS**, towing company owners have requested an increase in towing and
24 storage rates due to increases in the costs of operation; and

25
26 **WHEREAS**, the last rate adjustment was set in 2001 by Resolution R-22-01;
27 and

28
29 **WHEREAS**, the new rate adjustment reflects increases in the costs of operation,
30 and will not result in a windfall for licensed towing companies.

31
32 **NOW, THEREFORE, BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL**
33 that the towing rates for those towing companies licensed by the City of

1 Annapolis shall be stipulated in the table below:

12 **Minimum charges:**

14 If a vehicle is removed by the lawful operator or owner prior to the arrival of
15 a towing vehicle, there shall be no charge imposed by the towing company.

16
17 If the owner or operator arrives and agrees to remove the vehicle prior to
18 coupling ~~\$13.00~~ ~~\$25.00~~

19
20 After coupling (only if dolly is used) ~~\$27.00~~ ~~\$35.00~~

21
22 If the operator or owner refuses to pay these charges, the towing company
23 may proceed to tow the vehicle

24
25 ~~During weather-related emergency conditions declared for the City by the~~
26 ~~Annapolis Police Department, a 25% surcharge may be added to the basic~~
27 ~~tow charge~~

28
29 ~~An administrative fee of \$25.00 may be charged for those vehicles not~~
30 ~~claimed by the next business day following the tow.~~

35 **AND BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that
36 these towing rates shall take effect on the date of adoption of this resolution.
