# Peddlers, Hawkers and Itinerant Vendors License Application

## Instructions

A Peddlers License is required for persons seeking to sell commodities of any type and to ensure compliance with all applicable City Code regulations.

## Authority

Annapolis City Code and Charter, Chapter 7.40

#### Steps in the application process

- 1. The applicant obtains an application either on the website or at the office above.
- 2. The applicant and their employees submit an original and six copies of the application. Incomplete applications will be returned to the applicant.
- 3. The appropriate fee must be submitted with the application.
  - a. \$20.00 each day for periods not to exceed twenty days.
  - b. \$340.00 for periods in excess of twenty days.
- 4. The applicant provides two CURRENT photographs, two inches by two inches in size, showing the head and shoulders in a clear and distinguishing manner.
- 5. Submit a copy of the applicant's Driver's License.
- 6. Submit a copy of the vehicle registration.
- 7. If cooking or warming food will be done in the vehicle, you must provide either:
  - a. Three sets of drawings of the kitchen showing the commercial hood and duct and an extinguishing system to be installed by a licensed contractor; or
  - b. A letter from a Licensed Contractor confirming that the vehicle already meets NFPA 96 and NFPA 17.
- 8. DNEP reviews the application for completeness and distributes the information to City departments for evaluation.
- 9. The application is forwarded to the Mayor for evaluation and approval.
- 10. The license issued MUST be carried at all times and displayed in a conspicuous place.

#### Processing time

Processing of your application will take approximately two weeks. Please contact us after that time to determine the status of your application.

#### Enforcement

§7.40

Failure to obtain or violation of a permit in accordance with the City Code is a misdemeanor. Person(s) aggrieved by the decision may appeal a denial of the application in writing to the Board of Appeals within 15 days of the denial.

#### Other considerations and requirements

The Anne Arundel Health Department must inspect your equipment and vehicle. Contact this department at 410-222-7238 to schedule an appointment.
