The Ochoco National Forest, is advertising a Forest Service Campground Concession opportunity. The current special use permit will terminate on December 31, 2010. The purpose of this letter is to provide you notice and to solicit and invite interest from possible proponents. The permit will be for a 5-year term with an option to extend the permit for an additional 5-year term with operations to start in the spring of 2011.

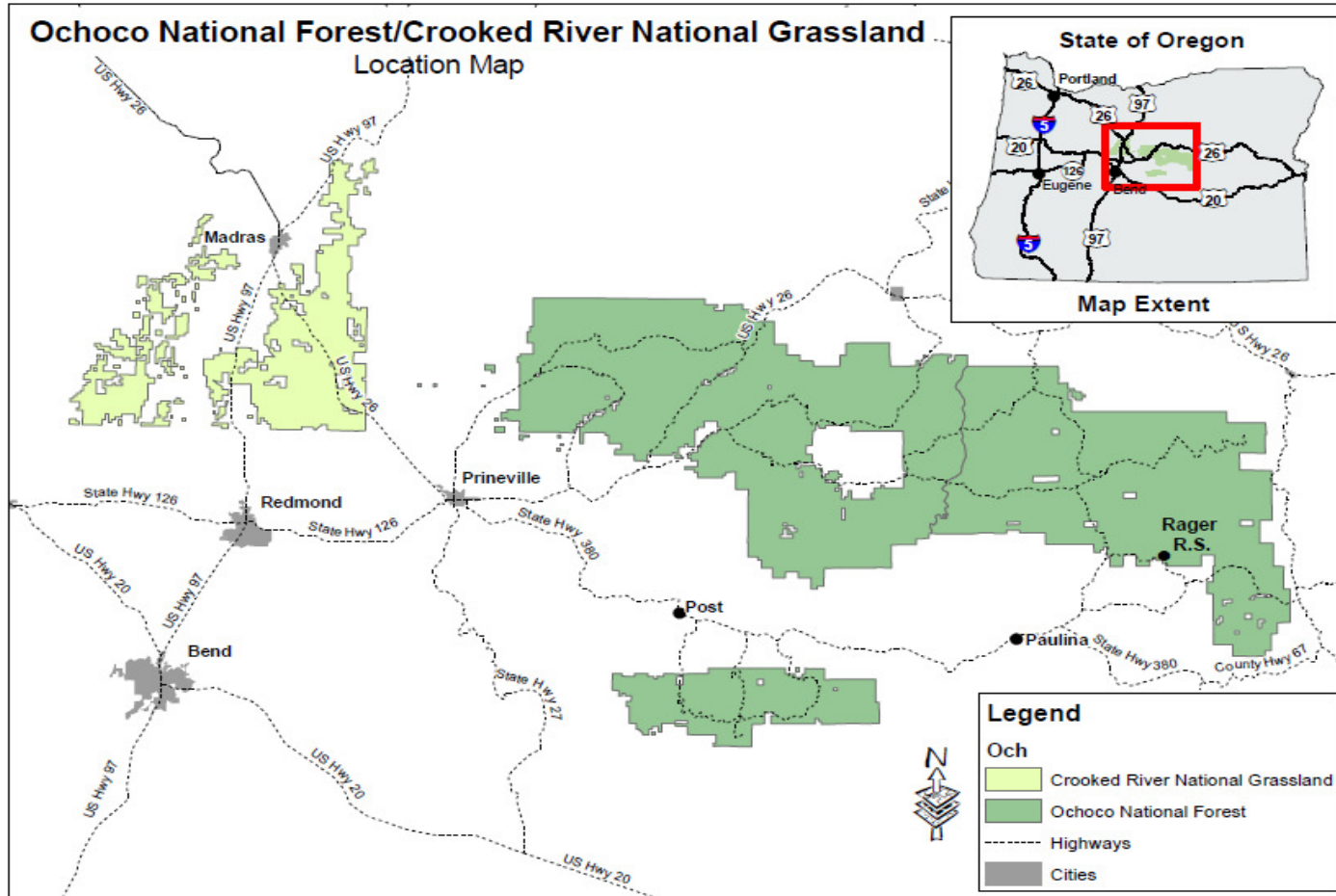

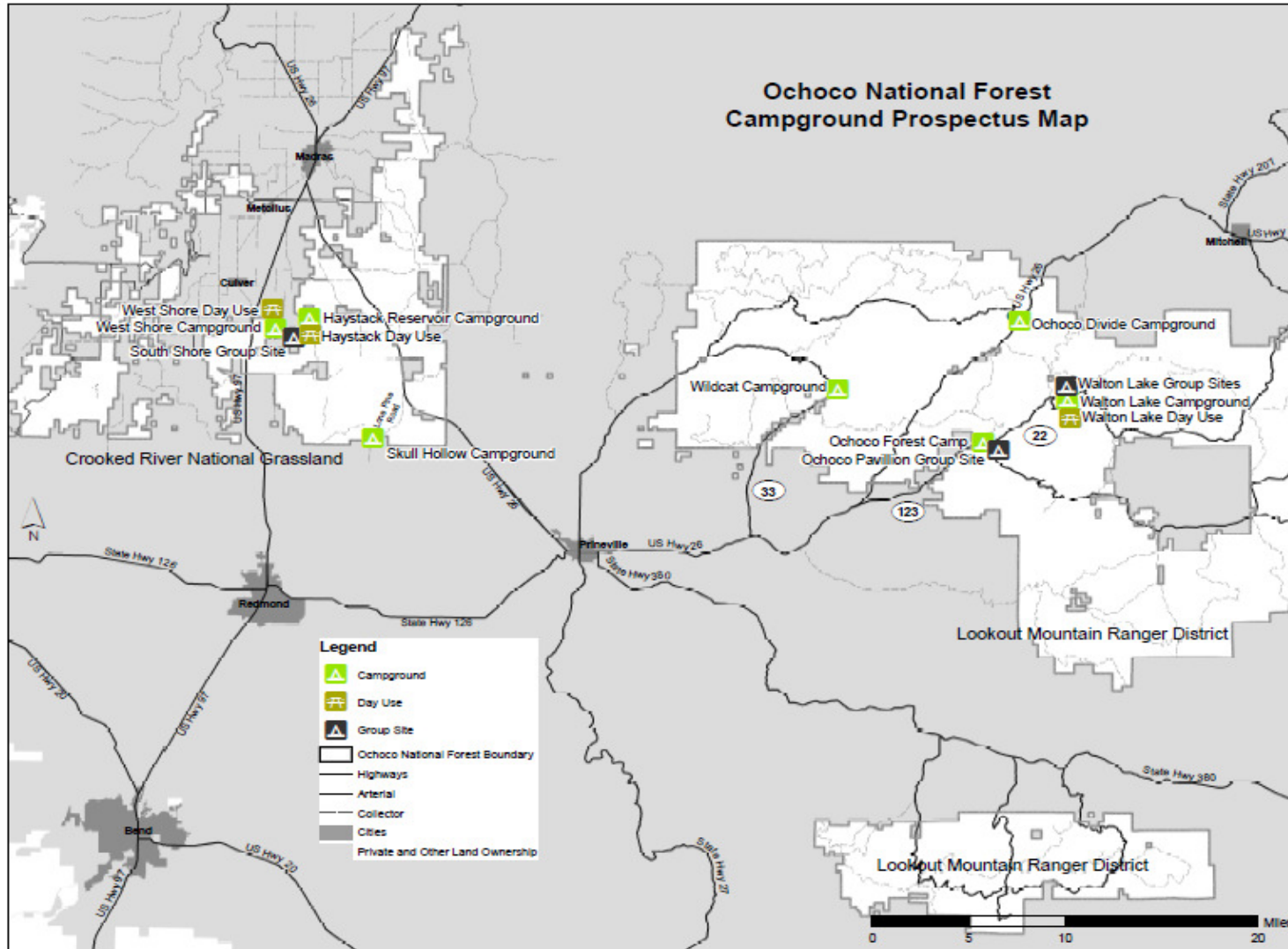
