CyberSafeKY Student/Adult Training Session and Franklin County Public Schools Technology Distribution

February 18, 10:00 a.m.

The virtual and physical worlds have blended into a digital society. However, most adults are still immigrants to this society, while those 18 and under are digital natives. Parents may believe that their child would tell them about their online experiences, but a recent study found that only about 25 percent of sexual solicitations and less than 40 percent of unwanted exposures were ever reported to parents. One might say responsible Internet use is similar to responsible driving — most parents allow their teens to drive but should educate their teen on safety and security. This session provides children with a basic understanding on safe use of social network sites, and what parents need to monitor in their children's use of the Internet. Topics covered include cyber bullying, cyber predators, responsible use of social networking sites and more. A brief technology distribution presentation will open the event.
