## 1. Other Contributions to Instructional Programs

(c) “International Network of Introductory Sociology Classes” (with Lisa Troyer and Michael Lovaglia), 1998 and continuing. This is a developing network involving introductory sociology courses in 11 countries (France, Germany, Iceland, Israel, Japan, Kenya, Netherlands, Norway, South Korea, Taiwan, and the United States). Sustained by a specially created Web page, e-mail linkages, and a paper document, “Notes on the Architecture of Village Greens.” Through the Web page, general news is circulated and participants can access library resources at the University of Iowa; intellectual discussions among faculty and students occur through the Web and e-mail; collaborative research involving students at the various national “nodes” is conducted and discussed through “chat rooms” and e-mail.

(d) “Doors into an Expanding Information Universe,” 1996-continuing. This is a major recasting in progress of the pedagogical system developed since 1973 for teaching research methods at the University of Iowa. Includes paper documentation, structured research experiences, and especially the use of five new university sites that students visit for training in cutting-edge sociological methods from experts on campus.
