TEMPORARY OCCUPANCY AND USE RESTRICTIONS

NATIONAL FOREST AREAS AND NATIONAL FOREST SYSTEM TRAILS AND ROADS

DESCHUTES NATIONAL FOREST

WILLAMETTE NATIONAL FOREST

Pursuant to 16 USC 551, 36 CFR 261.50 (a) and (b), the following special restrictions and prohibitions are established on Forest Roads, trails, and within the specific area on the Deschutes National Forest, Sisters Ranger District and the Willamette National Forest, McKenzie River Ranger District, in the State of Oregon, contained within the boundary lines described as follows and depicted on the attached map, hereby incorporated in this Order.

- · An area within a boundary line beginning at the trail head of Dry Creek Trail (#4050) located in Township 14 South, Range 8 East, Section 21, thence southwest along Dry Creek Trail for approximately I mile to its intersection with the western edge of Township 14 South, Range 8 East, Section 28, thence south along the westem edge of Section 28, to its intersection with southwest corner of Section 28, thence west along the south lines of Sections 29, 30, 25, 26, 27, and 28, thence north along the western edge of Township 14 South, Range 7 Y, East, Section 28 to its intersection with the Southeast comer of Township 14 South, Range 7 East, Section 24, thence west along the south lines of Sections 24, 23, 22, 21, and 20 to its intersection with the Highway 126, thence north along Highway 126 to its intersection with Forest Road 770, thence North along Forest Road 770 to its intersection with the McKenzie River National Recreation Trail (#3507), thence north along the McKenzie River National Recreation Trail to its intersection with Forest Road 2676, thence east along Forest Road 2676 to its intersection with Forest Road 2676866, thence east along Forest Road 2676866 to its intersection with Forest Road 2690810, thence east along Forest Road 2690810 to its intersection with Forest Road 2690, thence south along Forest Road 2690 to it most southern intersection with Forest Road 2690815 within Township 14 S, Range 7 E, Section 10, thence south along Forest Road 2690815 to its intersection with Big Lake, thence counter clockwise along the Big Lake shore line to its intersection with the middle of Township 14 S, Range 7 I, East, Section II, thence east through the middle of Section II to its intersection with the wilderness boundary, thence clockwise along the wilderness boundary to the beginning.
- · An area within a boundary line beginning at the intersection of Forest Road 2076 and the western terminus Forest Road 2076600, thence east along Forest Road 2076600 to its intersection of Forest Road 2068, thence southeast along Forest Road 2068 to its intersection with Forest Road 2068800, thence south along Forest Road 2068800 to its intersection with Forest Road 2067900, thence east and south along Forest Road 2067900 to its intersection with Forest Road 2067, thence south along Forest Road 2067 to its intersection with Forest Road 1028500, thence west along Forest Road 1028500 to its intersection with 1028600 thence northeast along 1028600 to its intersection with snowmobile trail #12, thence southeast on snowmobile trail #12, to the intersection of 2076900, thence north along 2076900 to its intersection with FS road 2076 to the beginning.

All Forest roads and trails contained within the area and boundary shall be closed with the following exceptions:

- · Highway 126
- · Forest Roads 2076600, 2068, 2068800, 2067900, 2067, 1028500, 2076930, 2076900, 2076, 770, 2676, 2690, 2690815, and 960
- · Forest Service system trails #3507, #104, and #102
- \cdot Forest Service system trail # 4050 until its intersection with the westem edge of Township 14 South, Range 8 East, Section 28

PROHIDITIONS

ORDER 06-01-05-11-002-5

It is prohibited to go into or be upon any of the above described lands which are closed for the protection of public health and safety. 36 *CFR* 261.53(e)

Being on a forest system road. 36 CFR 261.54(e)

Being on a forest system trail. 36 CFR 26J.55(a)

These restrictions are in addition to those prohibitions enwnerated in Subpart A of 36CFR26I and any other special restrictions pertaining to the described lands.

EXEMPTIONS

Pursuant to 36 CFR261.SO(e), the following persons are exempt from this order:

- 1. Personnel with written authorization by a Forest Officer, which specifically authorizes the otherwise prohibited act or omission. The issuing Officer may include such conditions as are considered necessary for the protection of the area, or for the promotion of the health, safety, or welfare of its users.
- 2. Any Federal, State, or local Officer or volunteer in the performance of an official duty.
- 3. Persons or their invitees who live or own property within the closure area, and permittees who have a legitimate need to access their permitted allotment, escorted or approved by IMT.

This closure is enacted due to firefighting activities taking place within the closure area, and for the protection of public and employee safety.

This order shall remain in effect for one year from the date signed, or until rescinded. This order replaces order 06010511002-4 which is hereby rescinded.
