Message *from the Director General*



Dear Colleagues,

The Airport Management Professional Accreditation Programme (AMPAP) is governed by a Steering Committee consisting

of ACI, ICAO, two elected representatives of AMPAP alumni and the AMPAP executive. ICAO Secretary General Raymond Benjamin and I co-chair the meeting, held at least once a year to assess how the programme is meeting our objectives and to affirm or adjust its direction. ICAO's Secretary General Raymond Benjamin and I co-chaired the meeting, which we hosted in our new Montreal ACI World Headquarters offices.

AMPAP, now at the four-year mark, has set the standard for a joint initiative between ACI and ICAO. The programme counts over 500 participants from 80+ nations, with 120 participants having earned their International Airport Professional (IAP) accreditation to date. This year we will offer courses in all regions of ACI. ICAO has followed through on its commitment to in the past year in delivering fellowships to AMPAP participants from developing countries, helping to achieve the objective of making the programme accessible to all airports. The programme boasts well balanced participation from all regions and all sizes of airports.

To further broaden the accessibility of the programme, we introduced the AMPAP Associate Diploma for non-airport industry stakeholders who now comprise approximately 10% of the total number of AMPAP participants, including management staff from World Business Partners, ACI and ICAO.

AMPAP dovetails well with a new ICAO initiative, "Next Generation of Aviation Professionals," (NGAP) launched last year. NGAP's objective is to ensure that sufficient qualified aviation professionals are available to operate, manage and maintain the future international air transport system. ACI shares ICAO's vision for professional development to keep pace with the industry growth forecasts and has participated in the NGAP launch symposium, Task Force meeting in February 2011 and the NGAP/TRAINAIR regional conferences in Incheon, Marrakech and Bucharest. Our collaborations with ICAO grow ever stronger.

We also seek greater collaborations with other industry stakeholders.

In early June, I attended the IATA Annual General Meeting in Singapore marking the transition in leadership from Giovanni Bisignani, who served for 9 years, to Tony Tyler, who comes to the position from the top job at Cathay Pacific. Our initial meeting with Tony in Singapore was most productive and we are committed to exploring ways to strengthen both our voices by working together.

ACI and IATA have a long history of close cooperation in the area of safety and security. We have also worked closely on a number of industry projects, such as, identifying the infrastructure demands for the A-380, jointly setting industry standards for common use passenger processing systems, and the environmental target-setting and awareness-raising efforts of the Air Transport Action Group (ATAG) of which we are each founding members.

The one area where ACI and IATA experience continuing friction is in regard to airport user charges, in spite of the fact that ICAO figures show user charges to be a small and stable proportion of airline operating expenses, under 4% over the past two decades. Our challenge is to educate IATA and its member carriers to recognize that airport business models have evolved considerably. Airline revenue is an ever-shrinking portion of total airport revenue, generally insufficient to cover the cost of the facilities and service to airlines. The growing source of revenue is that generated by passengers, through user charges and their purchase of services such as car parking and retail, and by airports' creative development of real estate outside of the terminal complex. Such diversified revenue streams are used to keep airline charges low while investing in airport infrastructure to ensure that future capacity can keep pace with demand. We intend to focus more attention on greater threats, such as the proliferation of aviation taxes, often disguised as environmental taxes, but which do not get invested in projects or programmes that will reduce greenhouse gas emissions or improve the industry's ability to mitigate its adverse environmental impacts or increase capacity. We share much common ground. Let us both strive to find it.

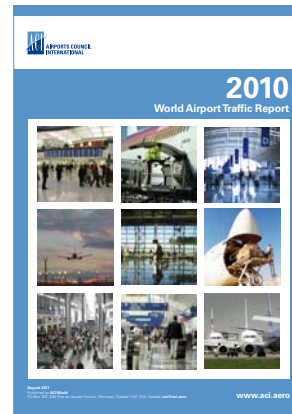

ACI World Standing Committees

Monthly webinars for the Security, Facilitation and Airport IT Standing Committees

Maintaining the interaction and the information flow between face-to-face meetings has always been one of the most important strategic challenges for the ACI World Standing Committees. In the past, this was done just by the use of email, which sometimes was not enough, as it could not provide real time interaction and opportunities for open discussions.

In April 2010, at the joint World Standing Committee meetings in Orlando, FL, the Committee members asked ACI World to leverage Information and Communication Technologies to enhance the work of the Committees between face to face meetings. As a result, ACI staff have worked hard to programme frequent webinars and conference calls for the Committees.

The 7th ACI World Security and Facilitation & Services World Standing Committees joint monthly webinar took place on 17 June, 2011, in two slots of one hour each, covering different time zones which enables high regional participation. The topics discussed were:

- World Governing Board direction on Facilitation
- Security of LAGs
- Next Generation Screening Checkpoint
- 100% Screening of persons other than passengers
- Next meeting of the ACI World Security Committee

The ACI World Airport IT Standing Committee (WAITSC) held its 8th webinar on 29-30 June

2011, in two slots to warrantee high regional participation. The following issues were covered:

- Action items from WAITSC last meeting in Stockholm
 - o ACRIS RP approval
 - o Common Use Working Group interaction
 - o Mobile phone applications and flow management technologies
 - o White Paper on Airport IT standards
- Preparation of the agenda and topics for the next WAITSC meeting
- Airport IT Trends 2011 Survey
- Agenda for Airport Exchange conference in Abu Dhabi

In addition, there was a specific webinar organised for the ACRIS WG on 16 June 2011, to discuss the project plan for the development of an ACRIS web-service to exchange Airport CDM information.

The member participation on these webinars has been very high, and the feedback received from Committee members has been very positive, with sustained productivity and outcomes.

PaxFlash and FreightFlash May 2011

May passenger growth strong, freight down slightly

Montreal, 5 July 2011 – Worldwide passenger traffic grew significantly in May. Total passenger numbers were up worldwide 6.6 per cent propelled by strong international demand across all regions with the exception of Africa (-16.5%), where key markets such as Egypt continue to feel the impact of the uprisings in several North African countries.

International traffic in Asia-Pacific expanded by 9.8 per cent, a very positive result even against the background of continued declines at Japanese airports following the earthquake and tsunami in March. Europe overall passenger numbers increased by 8 per cent as Turkey, Spain, Russia and Northern European countries generated significant growth.

Latin America-Caribbean registered the fastest growth rate at 15.3 per cent driven by very strong domestic demand in Brazil. Overall growth of 5.1 per cent in North America was helped by a 7.8 per cent expansion in international traffic. Results in the Middle East (+6.7%) were subdued by declining traffic in Bahrain.

Air freight volumes declined slightly, with international freight down 2.5 per cent and domestic freight down 0.4 per cent. The Latin America-Caribbean region, however, showed strong growth, up 14.8 per cent. Closer analysis showed this number driven by a surge in growth at Brazilian airports, with Sao Paulo (GRU) up 33 per cent and Rio (GIG) up nearly 32 per cent. Europe was the only other region in positive territory at 0.3 per cent. The Asia-Pacific region was down 5 per cent, with Hong Kong, Taipei and Seoul Incheon all declining by double digits.

ACI World's Economics Director Andreas Schimm commented, "We are encouraged by the continuing strong growth trend in passenger traffic. The decline in freight traffic is small in percentage terms and should be temporary as the corresponding period in 2010 represented the peak of the recovery. Most recent forecasts from the IMF predict robust GDP and trade volume growth in excess of 4 per cent. Passenger and freight growth are expected to remain well above that figure for the remainder of 2011."

Since the launch of The ACI Global Safety Network (GSN) training programme in 2006, almost 1,000 Operational, Safety and Emergency Planning Managers from airports spanning the globe have attended the very popular five day Courses.

Every delegate who completes each Module receives an ACI Certificate and upon completion of all three core Modules they receive the coveted ACI Diploma in Airport Safety Management – a “trophy” which is proudly displayed in many

airport managers offices throughout the world!

The 3 core modules are :

- GSN 1 – Safety Management Systems
- GSN 2 – Airfield Operations and Safety
- GSN 3 – Emergency Planning and Crisis Management

The three modules have become recognized as essential ‘core’ training for Airport Operational staff, providing the foundation for Airports to gain and maintain Certification through a team

of qualified operational personnel who not only have a working knowledge of ICAO Standards and Recommended Practices but are able to respond to incidents with confidence.

Over the six years since their introduction, each of the modules have been updated to take account of changes to ICAO SARPs and the ‘hands on’ experience of ACI Airport Operators.

The modules are well known for their highly visual Case Studies which examine in fascinating detail the key learning points for airports and regulators following accidents and incidents around the world and how these lessons can be implemented in practical terms through the airports SMS.

During each of the modules delegates are also able to view at close quarters the operations of the host airports. This may include visits to ATC Towers, Fire Stations, Driver Training Units and Crisis Management Centres.

All of the Instructors on the GSN courses are Senior Operational Managers who have extensive experience of implementing safety management systems and managing serious incidents/accidents at small, medium and large airports throughout the world. As such the facilitation of discussion between delegates and sharing of information is one of the many features which have made the courses a huge success.

AMPAP ATS Gateway Course in Male, Maldives *an inside look at airports enabling tourism*

The 34th offering of the AMPAP gateway course, Air Transport Systems, was hosted by the Maldives Airport Company in Male, Maldives 26 - 30 June. Participating in the class were managers with experience in several Maldivian airports, two large Indian airports, the Malaysian airports company and Berlin. Jean-Marc Trottier of Aviation Strategies International was the course leader, assisted by Paul Behnke, ACI's Senior Business Advisor, Wasim Zaidi (air and space law expert), and recent AMPAP graduate Sulaiman Zainal Abidin of Singapore Changi Airport.

Mr Trottier commented on the unique nature of this class: "This is the first time we have been

hosted by an airport at which over 80% of the passengers are tourists. Male International Airport serves as gateway to dozens of resorts on islands accessible only by seaplane or boat. As a result, Male has more seaplane operations than any other ACI member and operates a hub and spoke system which moves passengers from air plane to seaplane (and back), presenting

special logistical challenges. We learned a great deal about the specific nature of operations at Male and of the intense competition within the international market for tourist destinations. As is often the case, the course delivery team departed appreciating the inside look at another important sub-sector of our complex industry.”

The class benefited as well from a detailed briefing on the development plans for the airport from Andrew Harrison, CEO of Male International Airport, who described the changing passenger demographics with increasing numbers of tourists arriving from China on two Chinese carriers which recently began to serve Male.
