## Change of Date and Venue for Public Hearing

Notice is hereby given that the joint Public Hearing scheduled to occur on March 11, 2010, at the Beallsville High School has been postponed. The joint U.S. Army Corps of Engineers and the Ohio Environmental Protection Agency public hearing regarding The Ohio Valley Coal Company (TOVCC), Casey Run application has been rescheduled. This application has been submitted for a Department of the Army Permit under the provisions of Section 404 of the Clean Water Act (33 U.S.C. 1344). This Public Hearing is being conducted to ensure that every effort is made to identify and weigh all beneficial and adverse effects of the proposed activity as part of the National Environmental Policy Act and the Corps' Public Interest Review.

### **Background:**

TOVCC currently plans to construct a 12,908 acre-foot coal slurry impoundment (No. 3 Slurry Impoundment) that will receive slurry from both the Powhatan No. 6 D-0360 and American Energy Corporation D-0425 wash plants. The proposed project would directly impact approximately 29,928 linear feet (LF) of streams (6,426 LF Ephemeral, 13,928 LF Intermittent, and 9,574 LF Perennial) and 18 small wetlands (ranging in size from 0.003 acre to 0.11 acre) totaling 0.46-acres of wetlands. The proposed impoundment will be approximately 130 acres and have a total affected area of approximately 304 acres. Construction of the No. 3 Slurry Impoundment will be completed in three stages, plus a reclamation stage, that will provide 16 years of coarse and fine refuse disposal capacity. Additional details on the proposed activity can be found on Public Notice 04-38 dated December 5, 2009

All interested parties, including officials from local government, association, or private citizens whose interest may be affected by the proposed activity, are invited to be present at the above time and location. Oral statements supporting or opposing the proposed activity will be heard and written statements will be accepted. All statements will become part of the official CELRP-
