WORKSHOP ON THE PENNSYLVANIA STATE PROGRAMMATIC GENERAL PERMIT – 4 FOCUSING ON APPLICATION REQUIREMENTS AND LINEAR ACTIVITIES

NOTICE IS HEREBY GIVEN: A workshop on the recently revised Pennsylvania State Programmatic General Permit – 4 (SPGP-4) will be provided by the United States Army Corps of Engineers, Pittsburgh District Regulatory Branch. The SPGP-4 became effective on July 1, 2011 and is an integral part of joint permitting procedures between the Corps and PA Department of Environmental Protection. The focus of this workshop will be on application procedures related to permitting linear activities with multiple crossings, and submitting complete application for the overall project. This workshop will be most applicable to consultants, environmental professionals and industry representatives. Topics for discussion will include identifying the project purpose, limits of the overall project, and impacts to aquatic resources, as they relate to subsequent permit reviews and requirements. State Chapter 105 permitting requirements as wells as Endangered Species Act and Historic Preservation Act requirements will also be discussed.

DATE: Friday November 4, 2011, 9:00 a.m. – 12:00 p.m. (Check in will begin at 8:30 a.m.)
