Jerry L. Martin was born in Brown County, Texas near Lake Brownwood, and lived in the Brownwood area until he was four years old, at which time the family moved near Longview, in Northeast Texas. He graduated from East Mountain High School and then from Stephen F. Austin State University, in Nacogdoches, where he earned a B. A. in Business Administration with a minor in Economics. He also served as Vice-President of Alpha Phi Omega National Service Fraternity which contributed many services to the University and local community.

After the death of his wife (and high school sweetheart), he met Betty Capps, a Masonic widow, whom he married a year later. Jerry had one son and Betty had two daughters. Their family now has several grandchildren and great grandchildren which are a great joy to them.

After graduation from college, Jerry began his professional career in the J.C. Penney Regional Accounting office in Dallas, Texas. After three years he was hired by Zale Corporation as an Internal Auditor, and later was promoted to Vice President and Controller of the Sporting Goods Division. After leaving Zale Corporation, he was employed by Chromalloy American Corporation where he worked



on a campaign for a successful election to create a public transportation authority in Austin, Texas. After the election he helped create the finance and accounting departments and served as Assistant Director of Finance and Director of Accounting for Capital Metropolitan Transportation Authority. Later he was employed by the State of Texas Department of Human Resources where he was the Director of Information Technology Procurement and Contract Management until his retirement.

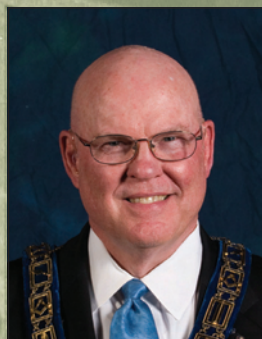

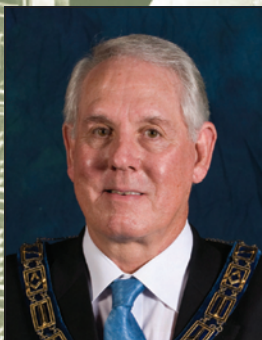

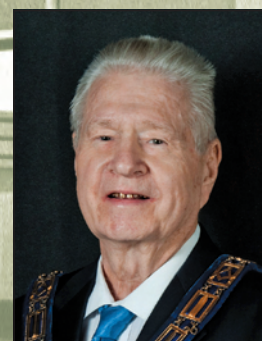

RESULTS OF THE 175th GRAND ANNUAL COMMUNICATION

Resolutions & Elections

RESOLUTIONS:

2009 Holdover Resolution No. 18 – Adopted. Removes Grand Lodge Officers from being Directors of the Board of Directors of the Masonic Home and School.

Resolution No. 1 – Not adopted

Resolution No. 2 – Not considered; failed 2/3's vote.

Resolution No. 3 – Tabled. Died at end of Grand Lodge, and must be re-submitted by May 15).

Resolution No. 4 – Withdrawn.

Resolution No. 5 – Adopted. Major John B. Jones Ranging Company of the Former Texas Rangers Foundation was recognized in Article 225a.

Resolution No. 6 – Adopted as amended. Amends Article 505.17 and prohibits canvassing publicly for or against the admission of a candidate into Masonry, the reinstatement of a suspended or expelled Mason, or the admission of an unaffiliated Mason.

Resolution No. 7 – Not adopted.

Resolution No. 8 – Withdrawn

Resolution No. 9 – Withdrawn

Resolution No. 10 – Withdrawn

Resolution No. 11 – Adopted. Adds Article 505.37 and prohibits making any negative reference or take any negative action in regard to a petitioner's or member's faith, creed, or race at any time.

Resolution No. 12 – Adopted. Amends Article 278 to require no person other than the Master shall wear any type of head covering, except for required religious head coverings, while in Lodge or at other Masonic ceremonies.

Resolution No. 13 – Not adopted

Resolution No. 14 – Adopted. Deletes the requirement for a petitioner to provide his full social security number on the various Masonic forms.

Resolution No. 15 – Not proper and not legal; therefore, not considered.

Resolution No. 16 – Not Adopted.

Resolution No. 17 – Withdrawn

Resolution No. 18 – Adopted as amended. Amends Article 6a to provide additional information on statements of availability.

Resolution No. 19 – Not adopted.

Resolution No. 20 – Adopted. Amends Monitor to add word "Amen" at various places in the Ceremony for Leveling a Cornerstone.

Resolution No. 21 – Withdrawn.

Resolution No. 22 – Not considered; failed 2/3's vote.

Resolution No. 23 – Withdrawn.

Special Resolution permitted by 4/5's vote to consider Investment Committee's proposal – Adopted. Amends Article 318a to permit the Grand Lodge Trustees to make a distribution from the Endowed Membership Fund by removing the \$100 cap on the worth of the endowment unit and using the interest and dividends revenue as a distribution source. Note: the first time for this potential distribution of interest and dividends gains will be August 2011.

GRAND MASTER'S RECOMMENDATION:

Grand Master's Recommendation – Adopted. Amends Article 163 and provides that the Grand Lodge Per Capita amount become \$25, effective 2012.

GRAND MASTER'S EDICT

To the Masons of Texas:

I have been advised that some Texas Masons presently belong to an organization operating under the name of "Widows Sons Masonic Motorcycle Riders Association". At the 2007 Grand Annual Communication this organization was denied recognition as an organization to which Texas Masons could belong.

Texas Masons are not permitted to belong to, or be identified with, the organization known as "Widows Sons Masonic Motorcycle Riders Association" unless and until such organization is recognized by the Grand Lodge of Texas, and to do so constitutes a Masonic Disciplinary Violation. This Edict is effective immediately. Acts contrary to this edict will result in Masonic Disciplinary action against the violator.

This edict is issued to enforce the 2007 decision of the Grand Lodge of Texas concerning the "Widows Sons Masonic Motorcycle Riders Association".

Fantastic Teeth Fan Club A Big Hit

The popularity of the Fantastic Teeth Fan Club, with both Masonic Lodges and children, has exceeded all expectations. The program was created by MCFS to help prevent children's tooth decay. As of the end of November 2010, more than 25 Lodges had agreed to partner with MCFS to provide free prevent tooth decay kits to first graders in their communities. In addition, nearly 80 Lodges were in the process of approving the program and working with MCFS to coordinate with local schools. The goal of distributing 5,000 prevent tooth decay kits, in the 2010-2011 fiscal year, looks like it will be a reality.

Irving Lodge #1218 was among the first to volunteer to launch the Fantastic Teeth Fan Club in their area. Lodge members assembled 225 prevent tooth decay kits and delivered them to two elementary schools. Several Lodge members accompanied MCFS staff as they taught a healthy teeth lesson to the children.

Butch Murden, Irving Lodge member, said, "This is a fantastic program. Today, we helped 160 kids learn the proper way to care for their teeth and even this old man learned a thing or two. This is truly a great program that will benefit many kids."

Teachers tell us children are delighted with their prevent tooth decay kits. John Ringhauser, principal at Davis Elementary said, "I heard one little boy say, 'Now, I have my own toothbrush.'"

Kits contain a toothbrush, toothpaste, floss, a timer for adequate brushing time, and dental education information in both English and Spanish for parents.

Message from the Grand Secretary...

The Seasons of New Beginnings

The 175th Grand Annual Communication had some of the most difficult issues to consider and yet it was one of the smoothest Grand Lodge sessions in decades. I applaud PGM Orville L. O'Neill for his leadership and I encourage the Masons of Texas to continue making our State a primary voice for Freemasonry in North America. Grand Master T. E. "Gene" Carnes' team is on track to make 2011 a stellar year in Texas Masonry.

We lost some giants in Texas Masonry during the past year. In addition to PGM W. P. Lamb, the Grand Lodge lost two emeritus giants – Grand Secretary James D. Ward and Grand Treasurer Arvol D. Willingham. They served together for years and they were buried within five days of each other. Jim Ward's funeral service included the *Hymn of Promise*, written by Natalie Sleeth and published in the *Methodist Hymnal*. The hymn provides an inspirational message, including the line "From the past will come the future; what it holds, a mystery, Unrevealed until its season, something God alone can see." We have several Masonic seasons to consider in preparing for 2011.

Lodges are near the mid-term of their Lodge Officers' year. The officers have followed the direction of PGM O'Neill for the first of their tenure and now Grand Master Gene Carnes will provide guidance for the remainder of their tenure. In 2011 Lodges will notice an emphasis on Masonic education and Masonic history. In January, the Worshipful Master (WM) should appoint the Committee on Members in Arrears. In addition to running the Lodge meetings, ensuring good degree work, and educating the officers, the WM also coordinates the preparation for any resolutions the Lodge may want to submit for the 176th Grand Annual Communication (due May 15), plans for the Grand Annual Returns, and arranges for Lodge elections and installations.

Lodge members are at the beginning of their dues season (January 1 to December 31). Members are required to pay dues before January 1; and if they do not, they become a "member in arrears." Lodge members must strive to become the best Mason they can. Attend meetings, participate in degrees, learn the esoteric work, read Masonic literature, study the laws of the Grand Lodge, review the Lodge Monitor, and research the Lodge history. A noble goal would be to update the Lodge history and relate Lodge events to local, national, and world history.

Grand Lodge officers are beginning their tenure. Grand Master's Conferences, DDGM visits, regional Masonic education programs, major Masonic historical events, mid-term DDGM briefing, Lodge installations, Warden's Retreats...the pace becomes a blur while giving directions and support to fulfill their leadership duties to Freemasonry.

As we enter 2011, let us take lessons from the past and apply them to problems of the future as the details of the Supreme Architect's plan are revealed to us.

The staff and I wish each of you a happy holiday season and a robust start to a new year of fellowship and Freemasonry.
