1. A person may apply to amend the list of species that can be imported to Tasmania under the *Nature Conservation Act 2002* by completing this form.
2. Applications will not be accepted without:
 - i. Completion of the applicant details and a signed declaration
 - ii. A draft species profile
 - iii. Relevant climate modelling files to support the species profile.
3. Further information for submitting an application, including preparing a species profile, is contained in the *Guidelines to Prepare a Species Profile to Amend the List of Wildlife that can be Imported into Tasmania* which are available on the Department's website.
4. It is recommended that you contact the Wildlife Management Branch (DPIPWE) in the first instance before developing an application (see below for details).
5. The information provided in the species profile will be placed on the Department's website and stakeholder submissions will be invited. Where the information supplied in the profile is not adequate it will be returned to the applicant to amend.
