

**Official Rules**  
**“10 on Top: Most Stylin’ Stars of the Year Trivia Sweepstakes”**  
**Sponsored by MTV**

1. NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.
2. **Entry Period:** The “10 on Top: Most Stylin’ Stars of the Year Trivia Sweepstakes” (the “Sweepstakes”) commences at 8:00:01 PM Eastern Standard Time (“EST”) on December 9, 2012 and ends at 11:59:59 PM (EST) on December 31, 2012 (the “Sweepstakes Period”). Entries must be received by 11:59:59 PM (EST) on December 31, 2012.
3. **Eligibility:** This Sweepstakes is open to legal residents of the fifty (50) United States and District of Columbia who are at least thirteen (13) years of age or older at the time of entry, Entrants must have a Twitter account to participate, Entrants who have not yet reached the age of majority in the jurisdiction in which they reside will need to obtain permission from their parents/legal guardians in order to enter be declared the Grand Prize Winner, if selected. Employees and their immediate families (*i.e.*, parents, spouse, children, siblings, grandparents, step parents, step children and step siblings) of Viacom Media Networks, a division of Viacom International Inc. (“Sponsor”), Toshiba America, Inc., Twitter Inc. (“Twitter”) and each of their respective affiliated companies, sponsors, subsidiaries, advertising agencies and third party fulfillment agencies (collectively “Sweepstakes Entities”) are not eligible to enter Sweepstakes. By participating in this Sweepstakes, entrants: (a) agree to be bound by these Official Rules and by the interpretations of these Official Rules by Sponsor, and by the decisions of Sponsor, which is final in all matters relating to the Sweepstakes; (b) release and hold harmless Sweepstakes Entities and its respective agents, employees, officers, directors, successors and assigns, against any and all claims, injury or damage arising out of or relating to participation in this Sweepstakes and/or use or misuse or redemption of the Grand Prize (as hereinafter defined); and (c) acknowledge compliance with these Official Rules.
4. **To Enter:** During the Sweepstakes Period, go to <http://twitter.com/10onTop> and tweet the correct answer to the trivia question announced by @10onTop along with the hashtag #10onTopFirst and the link to these Official Rules at <http://10ontop.mtv.com> (the “Tweet”) [e.g.] **[CORRECT ANSWER TO THE TRIVIA QUESTION] #10onTop rules: <http://10ontop.mtv.com>]**.

(Note: You will need to create a Twitter account if you don’t already have one. Membership on Twitter is free, and registration for Twitter can be obtained by logging on to <http://www.twitter.com> (the “Twitter Web Site”) and following the onscreen instructions to open an account.) BY RE-TWEETING THE 10onTop-SPECIFIED TWEET, YOU AGREE TO THESE OFFICIAL RULES. Although not required, we recommend you follow the official @10onTop” Twitter account located at <http://twitter.com/10onTop> so you can see the Grand Prize Winner’s announcement to see if you’ve won (pending verification) in addition to the Winner notification described in Section 5 below. Please note that if you do not respond the Grand Prize Winner notification described in Section 5, you will be disqualified and another Grand Prize Winner maybe selected. **You must manually tweet the correct answer to the trivia question along with the link to these Official Rules (exactly as it appears above) during the Sweepstakes Period to qualify as one (1) entry. Retweets using the Auto Retweet function are not permitted and will not be counted. One (1) entry per person allowed.** Automated Tweets or Tweets sent via a bot will be disqualified. All entries submitted in accordance with these Official Rules shall be hereinafter referred to as “Eligible Entries”. In the event of a dispute over who submitted a winning entry, the authorized subscriber of the Twitter account used to submit the winning entry will be deemed to be the winner. The authorized account subscriber is defined as the natural person who is assigned a Twitter account by Twitter. All entries become the property of Sponsor who shall have the right to edit, adapt, and publish any or all of the entries. Entries will not be acknowledged or returned. All entries must comply with the Twitter Terms of Service and Twitter Rules available at the Twitter Web Site. Creating multiple Twitter accounts in order to exceed the limits on entries permitted by these Official Rules may result in the disqualification of all entries from such accounts. Important note: If your Twitter account is set to “protected mode,” your updates/responses may not be visible in Sponsor’s @10onTop inbox and may not thus be received by Sponsor unless you previously consented to permit Sponsor to see the your Twitter updates. If you opt to use Twitter via your wireless mobile device (which may only be available via participating wireless carriers and is not required to enter the Sweepstakes), standard text messaging and/or data rates may apply for each message sent or received from your handset according to the terms and conditions of your service agreement with your wireless carrier. Other charges may apply (such as normal airtime and carrier charges) and may appear on your mobile phone bill or be deducted from your prepaid account balance. Wireless carriers’ rate plans may vary, and you should contact your wireless carrier for more information on messaging rate plans and charges relating to your participation in this Sweepstakes. Participation in this Sweepstakes by

**5. Winner Selection/Notification:** One (1) grand prize winner (the "Grand Prize Winner") will be randomly selected at the conclusion of the Sweepstakes Period by Sponsor, from among all Eligible Entries received. Sponsor will make up to two (2) attempts over the twenty-four (24) hour period following the Grand Prize Winner's selection on January 4, 2013 to contact the potential Grand Prize Winner via the Twitter account and via tweets from <http://twitter.com/10onTop>. If a potential Grand Prize Winner does not respond within twenty-four (24) hours of being contacted, such potential Grand Prize Winner will be disqualified and an alternate Grand Prize Winner will be selected from among the remaining applicable Eligible Entries received. This process will be repeated until a potential Grand Prize Winner responds.

**6. Winner Verification:** The potential Grand Prize Winner must prove eligibility, including, without limitation, proof of age and residence within three (3) days of being notified as a potential Winner. In the event of non-compliance by a potential Grand Prize Winner such potential Grand Prize Winner shall be disqualified and all privileges otherwise due as the Grand Prize Winner shall be terminated and an alternate potential Grand Prize Winner may be chosen from among all of the remaining applicable Eligible Entries received in Sponsor's sole discretion. **7. Grand Prize (1):** The one (1) Grand Prize Winner will receive one (1) Toshiba Satellite U925t Ultrabook Convertible laptop computer.

The approximate retail value ("ARV") of the Grand Prize is \$1,149.99 and the total ARV of all prizes to be awarded is \$1,149.99. No substitution or transfer permitted. The ARV is subject to change based on current market conditions at time of prize fulfillment. Any difference between the ARV and the actual value, if any, will not be awarded. The date for fulfillment of the Grand Prize will be approximately four (4) to six (6) weeks following the selection and verification of the Grand Prize Winner but such date is subject to change in Sponsor's sole discretion.

**8. General Prize Terms:** Arrangements for fulfillment of the Grand Prize will be made by Sponsor. All costs and expenses not specifically listed above, including, without limitation, any equipment to be used in connection with the Grand Prize are solely Grand Prize Winner's responsibility.
