### **Report of Current Research Activities:**

### Projects

- 1. Determining the effect of insulin upon protein metabolism in critically ill surgical neonates, PI
- 2. Development of a treatment algorithm to prevent infection in critically ill pediatric patients, PI
- 3. Prospective database collection that aims to define outcomes of necrotizing enterocolitis and incidence of short bowel syndrome. Site-PI
- 4. SPECS (safe pediatric euglycemia in cardiac surgery) trial. This is a prospective randomized trial of the effect of euglycemia upon clinical and nutritional outcomes in pediatric patients undergoing cardiac surgery. The primary outcome variable is the evolution of perioperative infections. Co-PI
- 5. 13C-methionine to determine liver function in children with short bowel syndrome. PI
- 6. Porcine model to assess nutrient absorption, bowel adaptation, bacterial overgrowth, and bowel motility in response to the Serial Transverse Enteroplasty (STEP) operation. PI
- 7. H13CO2 infusion to determine energy expenditure in critically ill neonates with necrotizing enterocolitis. PI
- 8. Randomized prospective trial of ethanol locks for the prevention of CVL infection in pediatric patients with short bowel syndrome. PI
- 9. Randomized prospective trial of enteral omega-3 supplements to limit hepatic injury in children with short bowel syndrome. PI

### **Report of Teaching**

### 1. Local Contributions:

- 2011-present Harvard Medical School Nutrition Course. A lecture on "The Metabolism of Critical Illness". This is for the whole first year class. The initial preparation time was six hours.

#### **b.** Graduate Medical Course:

### e. Advisory and Supervisory Responsibilities:

Since 1992 I have been an academic surgeon with full-time clinical responsibility for the training of Medical Students, General Surgical Residents and Pediatric Surgical Fellows. This involves approximately 20 hours per week. Further, I have managed a surgical nutrition laboratory over this same time period and this encompasses approximately 8 hours of weekly supervision of post-doctoral research fellows and students.

### f. Teaching Leadership:
