ADDENDUMN NO 1: INTERNATIONAL EXPRESSION OF INTEREST (EOI) FOR A REVENUE COLLECTION STYSTEM

In reference to the above mentioned tender KWS wishes to make the following clarifications/amendments;

- 1. That this is an "expression of interest (EOI)" and not a "RFP," hence the aim of the process is to confirm capability of firms and basic overview of their proposed products alongside other basic requirements for prequalification purposes. A detailed technical documentation will be required at the RFP stage.
- 2. KWS is not interested in a revenue share solution, but an outright purchase of a revenue collection system.
- 3. In the proposal, the bidder is expected to:
 - a. Give a summarized design of the system communication architecture
 - b. Possibly engage a communication partner (preferably in Kenya) to come up with a robust wide area network proposed solution that will enable their proposed system to communicate with the KWS head office in Nairobi.
 - c. Include the plan to supply the required infrastructure which will be required for wide area network connectivity
 - d. Plans to supply required server to run the proposed system which will be accessed by KWS users as a "private cloud" web based solution.
- 4. The proposed system is expected to integrate with the current KWS Financial system that runs on an SQL platform. This is to allow for revenue data to be shared with the financial system.
- 5. The various categories of KWS visitors visiting the parks all pay different park entry fees.
- 6. The bidders must have a minimum experience of 2 Years in revenue collection systems solutions.
- 7. Potential bidders are invited for a walk through of the current revenue collection process on **Wednesday**, **7**th **August**, **2013** at **KWS Headquarters**, **Nairobi** at **10:00am**.
